2. All these 4 applicants were granted two advance increments prior to implementation the recommendations of 6th Pay Commission. It is not in dispute that the recommendations Commission were brought into effect from 1.1.2006 retrospectively, though the G.R. was issued on 27.2.2009. Two advance increments were granted in favour of all these applicants in the year 2008, however, in view of the Government Resolution dated 24.8.2017 the fixation was done according to recommendations of 6th Pay Commission without taking into account the advance increments already granted in favour of the applicants. The said issue was pending for consideration before the Hon'ble High Court. It was the stand of the Government that when the employees concerned is getting higher

Salary because of the implementation of the 6th Pay Commission, he cannot be given double benefit by considering the advance increment granted in favour of the applicant in the year 2008 i.e. subsequent to the date of implementation of the 6th Pay Commission. However, though issue was before the Hon'ble Division Bench of the Bombay High Court Bench at Aurangabad, Hon'ble Division Bench held that "the Government Resolution dated 24.8.2017 will have prospective effect and not retrospective and in that case the benefit accorded to petitioner for excellent work in the year 2006, 2007 and 2008 shall not be withdrawn and if any recovery is made pertaining to the same, the same shall be refunded to the petitioner."

- 3. In view of the decision rendered by the Division Bench, eventually the State Government issued GR dated 15.12.2022 thereby clarifying the decision and giving directions to all the Government Departments for considering the advance increments granted to the employees while doing their pay fixation according to the recommendations of 6th Pay Commission.
- 3. In view of the aforesaid Government decision, as well as, in view of the law laid down by the Hon'ble Bombay High Court the applicants are entitled for grant

of 2 advance increments, which were already decided to be granted in their favour vide order dated 7.2.2009. Similar issue has been decided by this Tribunal also in T.A. No. 14/2022 with T.A. No. 15/2022 on 14.11.2022. In the circumstances, the Original Application deserves to be allowed and accordingly it is allowed in terms of prayer clause (B) and (C). There shall be no order as to costs.
