The learned Counsel for the applicant has contended that earlier the seniority list of cadre of Tribal Development Inspector used to be issued together with seniority list of cadres of Office Superintendent, Cultural Officer, Junior Administrative Officer and Research Officer. Therefore, the cadre of Tribal Development Inspectors should have been clubbed with the said cadres. Learned Counsel for the applicant has further contended that by clubbing cadre of Tribal Development Instructor with a larger cadre of Warden promotional avenues for former have been reduced.

3. Learned CPO has offered to submit a true copy of file notings while processing proposal for issue of Assistant Project Officer and other (Officer Class II) (Tribal Development Inspector) (Recruitment) (Amendment) Rules, 2017, covering relevant parts which deal with clubbing of various cadres for promotions vis-à-vis regular earlier identical provisions in Recruitment Rules, 1984, if any.

2. The matters appear to be interlinked in following manner:

(a) Based on seniority list as on 01-01-2017 which was finalized on 25-05-2017, 53 employees were promoted from Class-IV to Class-III. Aggrieved by this decision of respondents O.A.No.41 to 46 & 54 to 56, all of 2018 were filed before this Tribunal. Outcome/updates of these O.As. is not available on record nor the parties to the dispute have been able to provide any details. However, respondent authorities found mistakes in the seniority list as on 01-01-2017 and revised seniority list as on 01-01-2018 and also

found that out of 53 promotions made, 10 employees of Class-IV were wrongly promoted. Respondent authorities ordered reversion of these 10 employees.

(b) O.A. St.No.1110/2018 which was registered as O.A.No.589/2018 was filed by those aggrieved by the said reversion order and they filed M.A.No.221/2018 before this Tribunal which granted stay on reversion order vide the order dated 09-07-2018.

(c) O.A.No.531/2018, 532/2018, 671/2018 & 672/2018 were filed before Nagpur Bench of the Tribunal which did not pass separate order of interim relief in view of interim relief granted by this Tribunal in O.A.No.589/2018.

(d) A Contempt Petition has been filed bearing C.P.No.570/2018 in O.A.NO.702/2018, which is pending.
