2. It is the case of the applicant that he has undergone the selection process for the post of District Police Constable (शिपाई) and he has been duly selected for the said post. Learned Counsel submitted that even the document verification has also been completed. Learned Counsel further submitted that in the meanwhile the applicant came to be implicated in Crime No.06/2022 for the offences punishable Under Sections 419, 420, 467, 468, 471, 201 r/w. 34 of IPC. The respondents have, therefore, cancelled the selection of the present applicant. Learned Counsel submitted that the applicant is innocent and has been falsely implicated in the alleged crime on the basis of some wrong information.

3. Learned Counsel relying on the judgment of the Hon'ble Apex Court in the case of **Mohammed Imran Vs. State of Maharashtra & Ors. [Civil Appeal No. 10571/2018 (Arising out of SLP (C) No. 6599/2018** decided on 12.10.2018,

as well as, relying on the judgment of **Central Administrative Tribunal Principal Bench at New Delhi in the case of Guru Dutt Ranga Vs. Government of NCT of Delhi and Ors. [O.A. No. 2039/2005]** decided on 7.10.2005, submitted that only for the reason that the criminal prosecution is pending against the applicant, he cannot be denied an appointment when he has successfully undergone the selection process. In such cases, appointment order can be issued subject to outcome of the criminal case pending against the said applicant. Learned Counsel, in the circumstances, prayed for staying the effect and operation of the impugned order till decision of the present O.A.

4. In similar matter earlier also this Tribunal has passed an interim order thereby directing the respondents to keep one post vacant in the Open category. In this matter, now, same direction deserves to be granted. Thus, the respondents will be required to keep one post in Open category vacant.

5. Learned Presenting Officer submits that he will take the necessary instructions and will file affidavit in reply within shortest time. He has objected for grant of any interim relief as has been prayed for by the applicant. Learned P.O. has raised objection as about the territorial jurisdiction. The learned Counsel submits that since the

applicant is resident of Beed district, this Tribunal has territorial jurisdiction. Hence, issue of territorial jurisdiction is kept open.

6. After hearing the learned Counsel appearing for the applicant and the learned P.O. appearing for the respondents and after having gone through the documents placed on record, as well as, judgments relied upon by the learned Counsel for the applicant, I deem it appropriate to pass the following order: -

ORDER

(1) Issue notice to the respondents, returnable on 29-07-2022.

(2) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(3) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(4) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(5) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

As is revealing from the contents of the application, Criminal Case No. 85/2021 has been registered on 5th June, 2021 at Police Station, Rajur against the applicant for the offences punishable under Section 354(A) r/w. 506 of the I.P.C. The departmental enquiry has also been initiated against the applicant based on the said incident. It is the contention of the applicant that till the criminal case is decided by the criminal court the departmental proceedings cannot be initiated and conducted against the applicant arising out of the same incident and on the same set of facts.

3. Learned counsel for the applicant brought to my notice the charges leveled against the applicant in the

criminal case, as well as, charges which are framed in the departmental enquiry. In the present application the prayer made by the applicant is to restrain the respondent authorities from holding departmental enquiry pursuant to the memorandums dated 6.9.2021 and 9.10.2021 till finalization of the criminal case pending against the applicant. Learned counsel submitted that the department is however, bent upon to proceed with the departmental enquiry. He submitted that the departmental enquiry is being conducted in arbitrary manner and without following the principles of natural justice. He submitted that the applicant has demanded the relevant documents by filing proper application in that regard before the enquiry officer. However, only 4 documents are provided to the applicant and insofar as remaining documents are concerned, the applicant is advised to approach the concerned Police Station and to take the said documents therefrom.

4. Learned counsel Shri V.B. Wagh for the applicant has by way of interim relief prayed for restraining the respondents from proceeding with the departmental enquiry. However, granting such a relief would amount to granting final relief and, as such, that relief cannot be granted in favour of the applicant. Learned counsel further submitted that the respondents be directed to supply the relevant documents which the applicant has prayed for vide application dated 8.10.2021, so that the applicant may

be in a position to effectively defend the charge leveled against him in the departmental proceedings.

5. I have carefully perused the documents filed on record. At this stage it may not be proper to make any comment on merit of application filed by the applicant and more particularly whether the charge leveled in the departmental enquiry and criminal case are same so as to restrain the respondents from proceeding with the enquiry. The issue which needs to be dealt with at present is whether any such direction can be issued by this Tribunal to enquiry officer for providing the documents as prayed by the applicant to him along with the statement of charge. The respondents have provided the list of witnesses, as well as, the documents on which the respondents are placing their reliance. It appears to me that if according to the applicant, there are certain more documents which may have impact on the departmental enquiry, however, the same are not provided to the applicant, the relevant question can be asked to the witnesses or the the applicant may in his statement make reference to that. If according to the applicant, the material documents are not provided and if he succeeds in establishing the said fact that may be good ground for the applicant to seek quashment of findings, if recorded against him in the said enquiry. As such, I am not inclined to pass any order as has been sought by the applicant.
