Learned Counsel for the Applicants state that DPC for promotion to post of Jailor Group-I was held on 08.01.2024 by Additional Director General and Inspector General of Police (Prisons). The Applicants have cleared Departmental Examination within 3 chances, and therefore, they seek promotion to post of Jailor Group-I.</p> <p>3. Learned Counsel for the Applicants submits that Applicants failed twice in the year 2017 and 2018 in Departmental Examination. The Additional Director General and Inspector General of Police (Prisons) at that time after considering their failure in 2nd chance but giving them the 3rd chance, pushed them down in the Seniority List of 2021. The Additional Director General and Inspector General of Police (Prisons) changed the position of Applicant (i) Shri Rakesh Chavan from Seniority No.30 to 194 and (ii) Shri Amol D. Chaure from Seniority No.83 to 199. However, both Applicants cleared Departmental Examination in their 3rd chance. They appeared for their 3rd chance in Departmental Examination in January 2022 and result of this Departmental Examination was declared in October 2023. The Applicants were successful in this 3rd Chance and passed the Departmental Examination.</p>

4. Learned Counsel submits that in DPC which was held in 8th January, 2024, the names of the Applicants were not considered for promotion to the post of Jailor Grade-I.

5. Learned P.O. also admits that names of both Applicants were not considered for promotion to post of Jailor Grade-I. She submits that on 08.01.2024, the DPC was conducted and following remark is mentioned which reads as under :-

“ In the selection year 2023-2024, in accordance with the vacancies in the category of Jailor Group I and also considering the pending D.E./judicial case against some working officers upto Sr.No.123 in the seniority list of 1.1.2023 are considered for promotion and in said seniority list, the Applicants are at Sr. No.160 and 165, therefore, they have not considered for promotion.”

6. The Additional Director General and Inspector General of Police (Prisons) has to file Affidavit in Reply on the point that Seniority List was fixed as on 01.01.2021.

7. The Additional Director General and Inspector General of Police (Prisons) has to state on 'Affidavit in Reply', the fact that both Applicants have cleared Departmental Examination within stipulated 3 Chances which was considered while deciding position of these Applicants in Seniority List.

8. All the promotions to posts of Jailor Grad-I are hereby stayed.

9. Learned P.O. is granted One Week time to file Affidavit in Reply.
