Talekar, learned Advocate for the applicant, Shri Ajay Deshpande, learned Advocate for respondent No. 5, Shri Saket Joshi, learned Advocate holding for Shri Avinash Deshmukh, learned Advocate for respondent Nos. 7 to 8, Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent authorities and Shri Mahesh Deshmukh, learned Advocate for respondent Nos. 9 to 28 and Shri D.R. Shelke, learned Advocate for respondent No. 6.

2. Learned C.P.O. has submitted two documents, firstly, a copy of communication received by him from Section Officer, Public Works Department, Government of Maharashtra dated 03.02.2023 and secondly, a copy of Circular issued by PWD bearing No. ज्येष्ठता-२०२३/प्र.क. ०२/आस्था-१, dated 3.2.2023. Copies of the same were supplied to other parties. The learned C.P.O. has submitted copy of aforesaid communication received by him from State

3. Learned C.P.O. has already submitted seniority list of Junior Engineers as on 01.01.2022 published on 13.07.2022 and minor corrections applied to the same by issuing a Corrigendum dated 21.07.2022. Now, the learned C.P.O. has submitted "*corrected*" provisional seniority list as on 01.01.2022 published on 03.02.2023 superseding the one published on 13.07.2022. However, learned C.P.O. could not explain how seniority of absorbed Junior Engineers had been worked out by interpreting data tabulated in the 'corrected' provisional seniority list accompanying aforesaid Circular issued by Public Works Department, Government of Maharashtra bearing No. ज्येष्ठता-२०२३/प्र.क. ०२/ आस्था-१, dated 3.2.2023. For instance, seniority of the applicant No. 1 in this Original Application No. 826/2022 namely, Shri Mujibkhan Mehboob Khan Pathan has been shown at Sr. No 527 after assigning him seniority w.r.t. 26.02.1999 whereas, he had joined on the post of regular Junior Engineer on 24.6.1999. The response of the contesting parties to this *corrected/ revised* provisional seniority list published on 3.2.2023 is that the two applicants in O.A. No. 826/2022 find their grievance redressed but many others find loss of seniority to them without assigning any reason therefor.

4. Though the Public Works Department has, by aforementioned Circular, invited objection to the modified provisional seniority list as on 1.1.2022 published on 3.2.2023 within 10 days of publication of modified provisional seniority list; the process appears to be carried out in never-ending manner despite the fact that as per the orders of this Tribunal final seniority list has to be published expeditiously and it was expected by this Tribunal that the exercise of publication of final seniority list as on 1.1.2022 will be completed by the Public Works Department latest by today i.e. by 15.2.2023. As the time-line target has not been achieved by the respondent authorities therefore, it is necessary to issue further directions to the respondent authorities.

5. Learned C.P.O. clarified by submitting across the bar that about 13 Junior Engineers who worked on earthquake relief program and claimed benefit of reservation as Scheduled Tribe candidate and were absorbed as junior engineers have failed to submit their Caste Verification Certificate and, therefore, their names have been deleted from the present seniority list and incorporated in a separate list of supernumerary employees as per Government orders. He has further confirmed that while applying correction to the seniority

list as on 1.1.2022 published on 13.7.2022, following factors have been observed:-

- (a) Seniority position of no one was required to be lowered down on the ground of his / her failure to pass Professional Examination;
- (b) Seniority position of no one was required to be lowered down on the ground of his / her failure to clear Hindi and Marathi Examination; and
- (c) Only factor that has been applied, which has resulted into change in seniority list position is whether or not a temporary junior engineer has joined within prescribed joining time after order of absorption on the post of regular junior engineers was issued, following the provision of para 4 of Government Resolution dated 14.7.1998 (page No. 33 of paper book).

6. As mentioned in aforesaid para, above stated factors do not get reflected in the manner of making provisional seniority list so published on 03.02.2023 for which one example of seniority No. 527 has been cited. Learned C.P.O. is therefore, directed to submit a worksheet latest by 27.2.2023 depicting following details:-
