Heard Shri R.M. Patil, Applicant-in-person and Smt. Archana B.K., learned Presenting Officer for the Respondents.

2. The applicant is working as X-Ray Scientific Officer, Group-C, Sub District Hospital, Phaltan, District Satara. He states that he has submitted application dated 7.3.2024 to respondent no.1 pointing out illegality and malpractice in the transfers of Public Health Department which has taken place in 2023 and so also which is going to take place thereafter. He states that he wanted to know what steps were taken by Respondent-State pursuant to his complaint and therefore he has made an application dated 19.3.2024 under RTI. The Government by their letter dated 4.4.2024 have informed that pursuant to his application dated 7.3.2024 the Government has called the report dated 23.2.2024? (23.3.2024) and his application is thus disposed off. Applicant prays for enquiry report as well as action report.

3. Considering the relief asked ^{for} this cannot be a subject covered under the Administrative Law before this Tribunal as no right of the applicant is violated. There is no specific cause of action for which the applicant can approach this Tribunal. Moreover, it appears to be a subject of Public Interest Litigation (PIL) and therefore this Tribunal cannot entertain this OA as the grievance prayed is beyond its jurisdiction. The Tribunal cannot work as Information Officer beyond jurisdiction. Whatever relief is prayed is in the nature of information to get knowledge about enquiry report pursuant to complaint dated 7.3.2024. He may avail of other remedies. Hence, OA is dismissed.
