1. Heard Shri A.V. Bandiwadekar, the learned Advocate for the Applicant and Ms. N.G. Gohad, the learned Presenting Officer for the Respondents.
2. Learned P.O. for the Respondents Ms. N.G. Gohad prays for time for filing affidavit-in-reply.
3. Learned P.O. was called to state as to whether para-wise remarks are received.
4. Learned P.O. tendered the para-wise remarks.
5. On perusal of para-wise remarks it is evident that the same are extremely vague as there is no response to the aspect of binding nature of the G.R. dated 07.10.2016, (copy whereof is at Exhibit-T, page 201 of the paper book of O.A.) and applicants' entitlement to benefit thereof.
6. It is seen that para-wise remarks are furnished by Deputy Director and it cannot be made out as to whether those are furnished after obtaining approval from the Respondent No.3, Home Department.
7. It prima facie, appears that the matter is not being attended with required seriousness.
8. The matter is being pursued by the Applicant in the background that a policy decision is already proclaimed in the form of G.R. dated 07.10.2016. Therefore, prima facie, the State Government is not entitled to oppose O.A. like private litigants do, in a cantankerous manner and attitude. Therefore it is necessary to give directions to the Respondent No.3.

9. The Additional Chief Secretary (Home) is directed as follows :-

- (a) He should call for the papers of present O.A..
- (b) Read the case himself.
- (c) Find out whether O.A. is fit to be contested.
- (d) In case Additional Chief Secretary (Home) considers that present O.A. need not be contested, he shall take suitable steps, and in that event it shall not be necessary to file affidavit for contesting the O.A..
- (e) If he finds that O.A. deserves to be contested, he should record that he is satisfied that O.A. is required to be contested and thereupon he may authorize any Officer to file affidavit-in-reply.

10. By way of last chance four week's time is granted for filing affidavit in the event Additional Chief Secretary (Home) is satisfied that O.A. is to be contested.

11. Additional Chief Secretary (Home) is put to notice that if this Tribunal finds that O.A. is contested and this Tribunal ultimately holds that the contest is being done vexatiously and without there being legally available ground, consequence of personal costs to the officer who has recorded satisfaction as ordered in foregoing paragraph No.9(d), shall attract personal liability to pay costs without any separate personal notice to the officer concerned.
