though the departmental enquiry was commenced against the applicant when he was in service and it is completed in the year 2014 itself but the final order of punishment came to be passed on 04.10.2018. The applicant also remained under suspension near about 2 years. He was initially granted the provisional pension, however, the final pension came to be released in the year 2021.

- 5. Learned counsel for the applicant submits that younger son of the applicant is psychiatric patient and for his regular check-up, treatment etc. the applicant was required to visit hospital and to take care of him. However, during the outbreak of Covid-19, the husband of the real sister of applicant namely Rajaram Tukaram Zunjare expired on 13.10.2020 and the real sister of the applicant namely Pushpabai Rajaram Zunjare expired on 17.10.2020.
- 6. Learned counsel for the applicant submits that during the same period the applicant has also suffered from cardiac problem and Angioplasty was required to be done. However, during the outbreak of the said Covid-19 and consequential lockdown declared in the State of Maharashtra for the period

of March, 2020 till the end of 2021, the applicant could not approach this Tribunal by filing the Original Application.

- 7. Learned counsel for the applicant submits that in view of same, the delay has occurred. The delay is not intentional and deliberate one. The applicant prevented from sufficient cause to approach this Tribunal by filing the O.A. within time. Learned counsel for the applicant submits that the application thus deserves to be allowed.
- 8. Learned P.O. submits that there is an inordinate delay in filing the O.A. and despite the punishment inflected on the applicant in the year 2018, the applicant has approached the Governor by filing the appeal in the year 2021 for the first time and thereafter approached this Tribunal. There is no satisfactory explanation for such an inordinate delay. The application thus liable to be rejected.
- 9. The applicant is retired Government employee and he came to be retired way back in the year 2014. Thought the departmental enquiry was commenced and completed in the year 2014 when

he was in service, the final order of minor punishment was passed in the year 2018 i.e. after the gap of 4 years. Thereafter, the applicant had suffered from various family problems and also suffered from health problems as cardiac problem and Angioplasty was required to be done. Further the applicant could not approach the Tribunal within time due to outbreak of the said Covid-19 and consequential lockdown declared in the State of Maharashtra for the period of March, 2020 till the end of 2021.

10. In view of same, I am satisfied that the applicant has been prevented from sufficient cause to approach this Tribunal by filing the O.A. within time. The delay caused in filing the O.A. is not intentional and deliberate one. However, the applicant is required to be saddled with costs. In view of same, I am inclined to condone the delay caused in filing the accompanying Original by imposing costs upon the applicant. I compute the costs of Rs.200/- (Two Hundred only) on the applicant and proceed to
