06.07.2023 the applicant has submitted the representation for revocation of suspension, however, the respondents have not considered the said representation. Learned counsel for the applicant further submits that it is continuous case of action. Further there is no inaction on the part of the applicant. The delay is not intentional. Hence, the application may be allowed.

5. Learned P.O. for the respondents strongly resisted the application on the ground that the delay has not been satisfactorily explained. There is an inordinate delay of 1 year and 3 months which is not explained by the applicant. There is inaction and negligence on the part of the applicant. Hence, the application seeking condonation of delay is liable to be rejected.

6. It appears that by order dated 15.12.2021, the applicant come to be suspended in view of registration of crime. However, till today the applicant is under suspension as stated by the applicant. However, though the applicant has submitted the representation dated 06.07.2023, the respondents have not considered the same. It thus

appears that there is no inaction on the part of the applicant and there is a continuous cause of action since the applicant is still under suspension. In view of same and for the reasons stated in the application, the Misc. Application deserves to be allowed. Hence, the following order:-

- (i) M.A. No. 564/2023 is allowed.
- (ii) The delay of 1 year and 3 months caused in filing the accompanying O.A. is hereby condoned.
- (iii) Accompanying O.A. be registered and numbered in accordance with law.
- (iv) There shall be no order as to costs.
