1. Heard Shri R.R. Bangar, learned Advocate holding for  
Shri H.P. Jadhav, learned Advocate for the applicant and Shri  
B.S. Deokar, learned Presenting Officer for respondents.

2. By the present Original Application, the applicant is claiming following reliefs:-

*“B. By allowing this Original Application, kindly quash and set aside the order dated 15.11.2017 passed by the respondent No. 4 thereby rejected to review the order dated 26.07.2013 and not considered the termination period from 27.04.2004 to 14.12.2010 spent by the applicant out of service be not treated as a duty period for any purpose except pension.*

*C. By allowing this Original Application, further directing the respondent No. 4 to treat period from 27.04.2004 to 14.12.2010 as a duty period for all purpose and to extend him all consequential benefits attached thereto including benefits full pay and allowances for said period along with increments with interest.”*

3. It is an admitted fact that however without preferring any appeal, the applicant has challenged the decision of his Disciplinary Authority.

4. In view of the admitted facts, the Original Application is disposed of without any order as to costs with liberty to prefer such appeal before the appropriate authority.
