2. The present M.A. is filed seeking condonation of delay, which has occasioned in filing accompanying Review Application. The delay occurred is of around 100 days. In paragraph No. 2 of the application, it is contended that the order passed by this Tribunal on 02.11.2023 was not communicated to the present applicant and it came to the notice of this applicant only in the month of December, 2023. The contention as has raised by the learned counsel appearing for MPSC is seriously disputed by the learned counsel appearing for the applicant in O.A. He has placed on record the document showing that the order passed by this Tribunal was served upon the respondents in O.A. on 11.11.2023. Learned counsel was however, fair in further submitting

Law is well settled that while considering application for condonation of delay too technical approach is not to be adopted and it is to be kept in mind that ultimately the matters are to be decided on merits. The delay occasioned is not of very huge period. In the circumstances, we are inclined to condone the delay, which has occurred in filing accompanying Review Application. Hence, the following order: -
