- 4. Learned Advocate for Applicant further draws attention to advisory in 'Divisional Commissioner, Pune' letter dated 08.08.2024 to 'District Collectors' of 'Pune Division'; including about observance of 'Judgments' & 'Orders' passed by 'Courts of Law' while undertaking 'General Transfers: 2024'.
- 5. The 'District Collector, Pune' has issued 'Transfer Order' dated 14.08.2024 of 'Talathi' cadre during 'General Transfer 2024' but instead of Applicant has transferred 'Shri Ashok B. Kadam' on 'Vacant Post' of 'Talathi' at 'Dive', Tahsil Purandar'.

- 6. - 2. By order dated 14.08.2024 the Respondent no.1, P.W.D. ousted the Applicant from the post of Superintendent Engineer, Solapur and in his place Respondent no.2 is brought from the post of Superintendent Engineer, Public Work Circle, Yeotmal.
- 3. Learned Counsel has submitted that no CBS meeting was conducted by the Respondent-Department and Applicant has completed only two years and 10 months on the existing post. Applicant was promoted and posted by order dated 21.10.2021 from Ratnagiri to Solapur. Earlier Applicant was working as Executive Engineer at Ratnagiri. Respondent No.2 was earlier posted at Solapur, thereafter at Rashtriya National Highway Circle, Pune and on his request, he was transferred to Yavatmal on 24.03.2023. He has submitted that again on request of Respondent no.2, he was transferred from Yavatmal to Solapur at Applicant's in place of the applicant.
- 4. Learned P.O. has submitted that the Applicant has not served on the Private Respondent No.2. She has submitted that Respondent no. 2 joined the said post on the place of the applicant on 14.08.2024 at 6.15 p.m. Learned P.O is directed to inform Respondent No. 1 to serve notice on Respondent No. 2.
- 5. Learned Counsel Mr. Bandiwadekar has pointed out Exhibit-K letter dated 14.08.2024 sent by Mr. Atul Chakan, Chief Executive Engineer, Pune informing him that he cannot take unilateral charge when the applicant was on duty. Respondent No.2 was not relieved from his office at Yavatmal.
- 6. Learned P.O on instructions from Shri D.V. Kharke, Under Secretary, P.W.D, submits that Shri Dhotre, Respondent No. 2, handed over the charge to Shri Chandrakant Mehtre, Superintending Engineer, P.W.D after 12.00 noon

#### Tribunal's orders

- 7. Learned counsel for the applicant countering the submissions of learned P.O submits that the order of transfer dated 14.8.2024 was uploaded at 2.57 pm and as per Exh. K, page 81, the letter of Chief Engineer written to Respondent No. 2 on 14.8.2024, it is mentioned that Respondent No. 2 called Mr Chavan at 3.29 pm and that he be allowed to take charge and join.
- 8. I have gone through the letter and considered the submissions made by both the parties. It appears from the letter dated 14.8.2024 that there is something mysterious about the timing of handing over the charge at Yevatmal on 14.8.2024 and taking over charge at Solapur on 14.8.2024 at 6.15 pm, on the same day. Learned P.O further submitted that Respondent No. 1, PWD, has received email at 6.15 pm that Respondent No. 2 has taken charge at Solapur on 14.8.2024.
- 9. Though it is submitted that there are complaints against the applicant, still prima facie it appears that the applicant has good case on the point of transfer. However, it is necessary to give fair opportunity to both Respondent No. 1 & 2 to place more and correct facts about the transfer. Learned P.O to give answer why mandatory injunction in favour of the applicant and against the Respondent No. 2 is not to be issued.

- 1. Heard Shri A.V Sakolkar a/w Shri Amol Patil, learned advocate for the applicant, Shri A.J Chougule, learned P.O for the Respondents No 1 & 2 and Smt Punam Mahajan, learned counsel for Respondent No. 3 through Video Conference.
- 2. As per submissions of learned Counsel Ms. Mahajan order dated 14.08.2024 her presence is wrongly shown. However, she was not available on V.C when the matter was called out. Hence, speaking to minutes.
- 3. Learned Counsel Ms Mahajan seeks time to file affidavit-in-reply. At Serial No.15 (page 23) name of the applicant is appearing. He was making as competent authority committed in SRA Mumbai. By this order he was transferred as Deputy Collector, land acquisition, Centre-3, Panvel
- 4. By order dated 06.08.2024 at 4.45 status quo order was passed. Learned Counsel has submitted that as per the said order of status quo no transfer order should have been approved or issued by the Respondent.
- 5. Learned P.O. states that the file of SRA was moved to the Hon'ble Minister Mr. Atal Surve. The said file was approved by the Minister on 06.08.2024 at 4.00 pm and at 4.45 pm the Tribunal passed the order of status quo
- 6. Learned counsel pointed out that on 13.08.2024, Section Officer, Mr. Talekar issued order that Respondent No.3 should be posted and applicant should be relieved
- 7. On query made to learned P.O. in the presence of Officer, Shri Pravin Talekar Section Officer has submitted that unless Hon'ble Minister approves the file no officer can take charge or join SRA. I, therefore, asked the Respondent-Department whether at that time she has taken charge on 06.08.2024. Shri. Talekar informed that till today Respondent No.3 has not taken charge of the post.
- 8. Respondent No.3 is present in the Tribunal [P.T.O.

#### Tribunal's orders

- 9. The present Misc Application is filed by the applicant and prays that the impugned order dated 13.8.2024 thereby relieving the applicant from the post of Competent Authority No. 7, Slum Rehabilitation Authority (SRA) and joining the Respondent No. 3, on the post of Competent Authority No. 7, Slum Rehabilitation Authority (SRA), be quashed and set aside, as it is contrary to the order dated 6 .8.2024, wherein this Tribunal has directed Respondent No. 2 to maintain 'Status Quo'.
- 10. Learned counsel for Respondent No. 3, submits to the orders of the Court.
- 11. Learned P.O on instructions from Shri Pravin Talekar, Section Officer, Housing Department, produce copy of letter dated 16.8.2024, in which it is stated that Respondent No. 3, has not yet joined the office of Competent Authority No. 7, Slum Rehabilitation Authority (SRA) and the same is under consideration. The said letter is taken on record and marked as Exh. I. Learned P.O further submits that the Respondent-State is ready and willing to withdraw the transfer order dated 13.8.2024.
- 12. Hence, the oral statement of learned counsel for the Respondent No. 3, that she has taken charge is incorrect.
- 13. The letter dated 16.8.2024 does not mention that the transfer order is withdrawn. I am of the view that the Respondent-State ex-facie committed contempt of the order of this Tribunal dated 6.8.2024. In the letter dated 16.8.2024, the Respondents have not stated that they have withdrawn the order dated 13.8.2024. Now learned P.O submits that today the Respondents will issue the order cancelling the impugned order dated 13.8.2024. This statement is accepted.
- 14. Accordingly, Mis Application stands disposed of, as the Respondents are going to issue the order cancelling the impugned order dated 13.8.2024.
- 15. O.A No. 957/2024 (Caveat No. 30/2024) is already fixed on 26.8.2024.

- 2. Applicant challenges impugned order dated 13.10.2023 passed by the Respondent No.1 to the extent to which the same has issued the posting order to the Applicant on promotion to the post of Assistant Commissioner of Police to Nagpur City.
- 3. Learned Counsel has submitted that Applicant, working as Senior Police Inspector in the Welfare Department, Mira-Bhayandar challenges order dated 13.10.2023. Applicant is posted at Nagpur by way of promotion to the post of Assistant Commissioner of Police. Applicant challenges the order to the extent of his posting at Nagpur. Learned Counsel has submitted that the Applicant wants to be posted at the options given by him on the promotional post i.e. at any of the Police Commissionerate such as Mira Bhayandar, Thane, Mumbai, and Navi Mumbai. He seeks this transfer on humanitarian ground as his wife is suffering from stage 3 ovarian cancer which is detected in December, 2023. Applicant made representation on 20.01.2024.

#### Tribunal's orders

- 4. Learned P.O. has submitted that on 12.03.2024 the Applicant refused promotion on the ground that he cannot leave Mumbai and go to Nagpur as his wife is suffering from ovarian cancer. By letter dated 05.04.2024 the State informed the applicant the consequences of denial of promotion.
- Though the Applicant has refused the promotion it appears from the record and as per the instructions given by Mr. Venkatesh Bhat, Joint Secretary, Home Department to learned P.O. that the Department did not issue the order of cancellation of promotion of the applicant to the post of Assistant Commissioner of Police which was given to him by order dated 13.10.2023. Therefore as the promotion is not cancelled and the applicant has been working on the post of Senior Police Inspector continuously since 13.10.2023 till today and accepting the salary of Senior Police Inspector, Respondent-Department is directed to look into his general record and Medical papers of the wife of the applicant and if at all, it is the case required to be considered on humanitarian ground verify whether the applicant can be accommodated in any place at Mumbai on the post of executive.
- 6. Adjourned to 22.08.2024.
