



His services was terminated by order dated 21.2.2019. Thereafter the Hon'ble High Court quashed and set aside the impugned FIR by order dated 25.11.2019. The applicant moved the Respondent-State by application dated 18.2.2020, 28.2.2020, 25.3.2020 and 16.3.2021.</p> <p>5. Dr. Gauri Rathod, Deputy Director, Health Services, Thane, based on the representation of the applicant, has submitted the report to the Commissioner, National Rural Health Mission, that the order be issued for appointment of the applicant. However, on 19.4.2021, the Commissioner, National Rural Health Mission, refused to reinstate him on the applicant that the applicant has misbehaved when he was in service. Thereafter, by order dated 18.5.2021 Deputy Director, Public Health Services also communicated the said decision to the applicant, which is subject matter of challenge in this Original Application.</p> <p>6. When the matter appeared on Board on 3.8.2021 the Tribunal has noted that the applicant had served as ad hoc Medical Officer for 11 years from 2008 to 2019 and the FIR is quashed by the Hon'ble High Court, Bombay.
