- 6. Therefore, Learned P.O was directed to furnish name of the Secretary concerned which he has furnished, as follows:-

Shri Mahesh Pathak, Principal Secretary, Food & Civil Supplies Department, Govt. of Maharashtra, Mantralaya, Mumbai.

- 7. Shri Mahesh Pathak, Principal Secretary, Food & Civil Supplies is directed that he should explore, search, find out and state on his own affidavit, the following:-
 - (i) Whether it was a conscious decision to withhold these documents.
 - (ii) The reasons due to which entire set of documents was not produced.


