2. In the present O.A, the directions are sought to include the names of Applicants in the select list dated 26.10.2018 prepared for grant of promotion by considering the initial date of absorption as 26.10.2010 by correcting the seniority lists published in the year 2017 as well as 2018 of the State Government employees of Grade 'C' in Accounts and Audit Branch.

3. As such, the issue raised in the matter pertains to seniority list as well as promotion list prepared by Respondent Nos.3 and 4.

4. Learned Advocate for the Applicants prayed for interim relief on the ground that, if promotions are made on the basis of select list dated 26.10.2018, then in that event, the Applicants would be the sufferer.

5. Whereas, learned C.P.O. sought time to file reply in detail, as the matter pertains to seniority and entitlement to promotion.

6. At this juncture, without making any comment on the merit, it is enough to observe that any promotions, if made, on the basis of select list dated 26.10.2018 would be always subject to the outcome of this O.A. This will take care of the Applicants' apprehension of denial to promotions, if later found entitled to be included in the list.

7. In view of above, issue notice returnable on 20th December, 2018.
