Learned Advocate for Applicant states that as per 'Advertisement' dated 29.02.2024 published by 'Commissioner of Police, Greater Mumbai' total of 257 'Vacant Posts' of 'Police Constables' have been kept aside to be filled through 'Inter District Transfer' from amongst 'Police Constables' who are serving in various establishment under 'Additional DG, SRPF, Maharashtra State, Mumbai'.

3. Learned Advocate for Applicant thereupon mentions out of total 257 'Vacant Posts' of 'Police Constable' earmarked to be filled by 'Inter District Transfer' as per 'Advertisement' dated 29.02.2024 published by 'Commissioner of Police, Greater Mumbai'; based on information available in 'Public Domain' about 210 'Vacant Post' of 'Police Constables' have already been through 'Inter District Transfer' approved by 'Additional DG, SRPF, Maharashtra State, Mumbai'.

4. Learned Advocate for Applicant then contends that total of 47 'Vacant Posts' of 'Police Constable' are still available on establishment of 'Commissioner of Police, Greater Mumbai' which are can be filled-up through 'Inter District Transfer'; but for this appropriate action has to be taken by 'Additional DG, SRPF, Maharashtra State, Mumbai'.

Learned P.O. states that no specific information is available about what course of action would now be taken by 'Additional DG, SRPF, Maharashtra State, Mumbai' to fill-up total of 47 'Vacant Posts' of 'Police Constable' through 'Inter District Transfer' which are still available on establishment of 'Commissioner of Police, Greater Mumbai'; so as to bring to closure the ongoing recruitment drive for total 2572 'Vacant Posts' of 'Police Constables' as per on 'Advertisement' dated 29.02.2024 published by 'Commissioner of Police, Greater Mumbai'.

6. The 'Additional DG, SRPF, Maharashtra State, Mumbai' has not yet filed 'Affidavit-in-Reply'; although (i) 'Commissioner of Police, Greater Mumbai' has filed 'Affidavit-in-Reply' on 09.10.2024 and (b) 'Commandant SRPF Group 1, Pune' has filed 'Affidavit-in-Reply' on 09.10.2024. Hence, for expeditious consideration of grievance of Applicant which is for 'Inter District Transfer' from establishment of 'Commandant; SRPF Group-1, Pune' to establishment of 'Commissioner of Police, Mumbai'; the 'Additional DG, SRPF, Maharashtra State, Mumbai' is informed to file 'Affidavit-in-Reply' within 'Four Weeks' about course of action proposed to be taken regarding consideration of representations submitted by Applicant on 16.02.2024 and on 07.08.2024 about request for 'Inter District Transfer' with reference total of 257 'Vacant Posts' of 'Police Constables' earmarked as per 'Advertisement' dated 29.02.2024 published by 'Commissioner of Police, Greater Mumbai'.


