2. Applicant has preferred the present Original Application challenging order dated 10.1.2023 whereby the applicant has been suspended by respondent no. 1 in contemplation of the Departmental Enquiry against him as mentioned in para 1 of the impugned order. The learned counsel submits that the allegations against the applicant are apparently false and even if all these allegations are proved, they may not entail in grant of any major punishment. In the circumstances, according to the learned counsel, the order of punishment is not warranted. The learned counsel submits that if the nature of allegations are seen wherein the applicant is required to be put under suspension even the DE is initiated against him. The learned counsel, in the circumstances, has prayed for staying the further proceedings of the said DE till the decision of the present OA.

- 3. The learned Chief Presenting Officer has opposed for grant of any interim relief as has been prayed by the applicant till the affidavit in reply is filed by the respondents. The learned CPO has sought time of 3 weeks for filing the affidavit in reply. The learned CPO submits that it is well within the powers of respondent no. 1 to put an employee under suspension in contemplation of the DE, if in its opinion suspension is necessary. The learned CPO reiterated for rejecting the request of the applicant for interim relief.
- 4. I have duly considered the submissions advanced on behalf of the applicant and the respondents. I have also gone through the documents filed on record. At this juncture it is difficult to reach to any conclusion whether the allegations are false or as about seriousness about the allegations raised against the applicant. If an enquiry is contemplated against any Government servant, under rule 4 of Maharashtra Civil Services (Discipline & Appeal) Rules, 1979 it is well within the powers of the employer to put an employee under suspension. At this juncture no certain conclusion can be recorded. In the circumstances, interim stay as has been prayed for by the applicant cannot be granted unless the respondents put their affidavit in reply on record. In the circumstances, I deem it appropriate to pass the following order:-

The present Original Application is filed seeking to challenge the Departmental Enquiry initiated against the applicant by issuing impugned charge sheet dated 03.08.2022 (Annexure A-6) allegedly on the basis of registration of criminal case against him and seeking stay to the hearing of the said Departmental Enquiry.

2. The applicant is the Government servant being posted as Laboratory Technician on 09.09.1997. He is working in Bhausaheb Hire Government Medical College and Hospital, Dhule. On 04.03.2022 while in Government service according to the applicant, one frivolous and false complaint lodged against him and others alleging that on 04.03.2022 at 10.30 am the applicant and others formed unlawful assembly armed with dangerous weapons near house of informant / complainant and raking up the issue of gram panchayat election in the year 2017

voluntarily caused to grievous hurt to the informant / complainant and witnesses and thereby committed offence under Section 326, 324, 504, 506, 143, 147, 148, 149 of IPC and under Section 37(1)(c) and 135 of the Maharashtra Police Act, 1951. It is the contention of the applicant that the departmental charge-sheet is issued based on the allegations in the criminal case. Charge sheet dated 11.07.2022 (Annexure A-5) was filed before the Court of Chief Judicial Magistrate, Dhule.

- 3. Heard Shri K.B. Jadhav, learned Advocate for the applicant and Shri B.S. Deokar, learned Presenting Officer for the respondent authorities.
- 4. Perusal of the memorandum of charge-sheet in D.E. dated 03.08.2022 (Annexure A-6) allegedly served upon the applicant on 02.01.2023 in the background of charge sheet dated 11.07.2022 filed before the Chief Judicial Magistrate, Dhule would show that the charges in D.E. are identical. Moreover, witnesses in D.E. appearing at page No. 50 of the paper book in Schedule-3 would show that as that of witnesses in criminal case. In view of the

same, in our considered opinion, while defending memorandum of charges in D.E., the applicant has to disclose his defence in criminal case, which is likely to cause prejudice to the applicant. In view of the same, in our considered opinion, refusing to grant interim relief of stay to the D.E. is likely to defeat the cause of justice. Hence, this is a fit case of grant of interim relief of stay to the hearing of Departmental Enquiry till filing of the affidavit in reply by the respondents. It is ordered accordingly.

The present Original Application is filed seeking direction not to proceed with the departmental action initiated against the applicant vide memorandum dated 18.02.2022 (Annexure A-4) till the conclusion of Special Case (ACB) No. 206 of 2021 pending before the Additional Session Judge-II, Jalgaon and further seeking interim relief of deferring departmental proceedings.

2. While the applicant was posted to work at Jalgaon as District Special Auditor Class-I of Cooperative Societies, he came to be implicated in ACB case alleging to have demanded an amount of Rs. 52,000/- for sending a favourable report regarding the Audit Reports conducted by the complainants of various Co-operative Societies. Special Case (ACB) No. 206/2021 came to be registered on the basis of charge-sheet filed.

Incidentally the respondent No. 1 under memorandum dated 18.02.2022 (Annexure A-4) ordered disciplinary action allegedly predominantly circling around the incidence of ACB trap conducted on 05.08.2020. This has laid the applicant to run a risk of disclosure of his defence in criminal prosecution during enquiry, which the applicant seeks to assail in this Original Application.

- 5. Perusal of the impugned charge-sheet dated 18.02.2022 (Annexure A-4) in the background of the charge-sheet in a criminal prosecution dated 21.10.2021 (Annexure A-1) on the basis of which the Special Case (ACB) No. 206/2021 is registered, would show that the charges in the Departmental Enquiry are based on the facts of criminal case and the misconduct is alleged only in respect of those allegations only. Moreover, in the list of witnesses annexed to the departmental charge-sheet as Annexure A-3 would show that most of the

witnesses are those witnesses who are cited in criminal prosecution. In these circumstances, in our considered opinion, if the Departmental Enquiry continues, the applicant is at a risk of disclosure of his defence in criminal prosecution during D.E., which would be prejudicial to the applicant. In these circumstances, this is a fit case to grant interim relief of directing the respondents to defer the departmental proceedings initiated against the applicant vide memorandum dated 18.02.2022 (Annexure A-4) until further orders. It is ordered accordingly.
