Heard Shri Nagesh Talekar, learned counsel for the applicant and Shri S.K. Shirse, learned Presenting Officer for the respondent authorities.

- 2. Learned counsel Shri R.N. Bharaswadkar, has appeared on behalf of respondent No. 5 and sought time to file **VAKALATNAMA** and affidavit in reply on behalf of said respondent.
- 3. Learned counsel for the applicant pointed out that the respondent No. 5 has filed O.A. St. No. 1824/2023 and has secured interim relief from this Tribunal, on the basis of which his application has been accepted and he has participated in the recruitment process of Kotwal for Sajja Atala. It is the contention of the present applicant that respondent No. 5 is not resident of Sajja Atala. Learned counsel for the applicant submitted that the applicant stands at Sr. No. 2 in the merit list. It is

the further contention that since respondent No. 5 was permitted to participate in the recruitment process subject to outcome of the petition filed by him, unless said O.A. is decided the appointment order cannot be issued in favour of respondent No. 5. He has therefore, prayed for directing respondent authorities not to proceed further in the recruitment process of Kotwal for Sajja Atala till decision of Original Application filed by respondent No. 5. The order passed by this Tribunal in O.A. St. No. 1824/2023 is placed on record.

4. After having considered the submissions made and after having gone through the documents filed on record, there appears substance in the contentions raised on behalf of the applicant and the relief as has been sought therefore deserves to be granted. Hence, the following order:-

ORDER

- (i) Issue notices to the respondents, returnable on 07.11.2023.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

- (iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- (v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
- (vi) The respondent authorities are directed not to proceed further in the recruitment process of Kotwal for Sajja Atala until further orders.
- (vii) S.O. to 07.11.2023.
- (viii) Steno copy and Hamdast is allowed to both parties.

Heard Shri H.P. Jadhav, learned counsel for the applicant and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent authorities.

- 2. It is the grievance of the applicant that though he has passed the Sub-Service Departmental Examination within the stipulated period and stipulated chances, the respondents have considered the seniority of the applicant in the cadre of Talathi from the date of passing of Sub-Service Departmental Examination.
- 3. learned counsel for the applicant submitted that the applicant belongs to Scheduled Caste (S.C.) category and for the S.C. candidates the period provided for passing the Sub-Service Departmental Examination is of 5 years and in 4 attempts as per the G.R. dated 24.08.1976. Learned counsel submitted that the applicant has passed the Sub-

Service Departmental Examination within the period stipulated as above and as such, his seniority must have reckoned from the date of joining the services. Learned counsel submitted that since in the final seniority list his name has been placed considering his of date Sub-Service passing Departmental Examination, his juniors are placed ahead of him and he is likely to lose chance for his promotion in the cadre of Circle Inspectors. Learned counsel submitted that the process for granting promotion is in progress. Learned counsel in the circumstances has prayed for directions against the respondents to keep one post in the cadre of Circle Inspector vacant till decision of the present Original Application.

- 4. Learned C.P.O. has sought time to take instructions and accordingly to file affidavit in reply on behalf of respondents.
- 5. Learned counsel has placed reliance on judgments delivered by this Tribunal on the issue that the seniority of the applicant is to be reckoned from the date of his joining the service after he has passed the Sub-Service Departmental Examination within stipulated period and stipulated chances.

- 6. After having considered the facts as aforesaid, we are convinced that a *prima-facie* case is made out by the applicant for issuance of interim relief as has been prayed for in the Original Application.
- 7. Learned counsel for the applicant submits that the applicant is at present not having complete addresses of respondent Nos. 3 to 11. Learned counsel in the circumstances, has prayed for service of notice to the said respondents through the District Collector, Latur.
- 8. From the title clause of the O.A., it appears that the Tahsil Offices under which the respective respondents are working is known to the present applicant. In the circumstances, service of notice to respondent Nos. 3 to 11 is permitted through their respective Tahsil Office, under which the said respondents are working. In the result, the following order is passed:-

Heard Shri A.V. Thombre, learned counsel holding for Shri S.S. Thombre, learned counsel for the applicant and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent authorities.

- 2. Learned counsel for the applicant submits that name of the applicant has been wrongly recorded in the O.A. as "Vilas" instead of "Vikas". Learned counsel has sought leave to correct the name of the applicant. Leave granted as prayed for. The said correction be carried out forthwith.
- 3. The applicant had applied for the post of Staff Nurse in pursuance of the advertisement published on 10.5.2023. As is contended in the Original Application, the applicant applied for the said post as Open candidate. The applicant also appeared for the written examination and successfully passed the said examination. The name of the applicant is also

included in the merit list. The applicant has now come out with a request that the respondents be directed to consider the candidature of the applicant as a Project Affected Person (for short P.A.P.). The learned counsel for the applicant submitted that at the relevant time, since the certificate of P.A.P. was not possessed by the applicant, he did not apply for the subject post for the P.A.Ps. claiming reservation In the circumstances, the present O.A. is filed seeking directions against the respondents for considering the candidature of the applicant for his selection to the post of Staff Nurse from 'Open- P.A.P.' category, instead of Open category.

4. The applicant has placed on record the copy of the application form, which was submitted by him. In the said form against the question "Are you Project Affected?", the applicant has recorded the answer in negative i.e. "No". The explanation given by the applicant for recording such answer is that on the date of making application, he was not having in his possession the certificate of P.A.P. The learned counsel for the applicant submitted that the applicant had applied for P.A.P. certificate in the

year 2019 itself, however, it was not issued till 7.8.2023. The learned counsel submitted that for the delay committed by the authority concerned the applicant cannot be deprived of the benefit as Open – P.A.P. candidate. Learned counsel submitted that scrutiny of the documents is yet to take place and in the circumstances there may not be any difficulty in directing the respondents to consider the candidature of the applicant as Open-PAP candidate.

5. The contentions raised in the Original Application and the prayers made therein are liable to be rejected at the threshold even without issuing notice to the respondents. The benefit of being project affected person, which was not claimed by the applicant while filling in the application form and more importantly when in the application form against the question "are you Project Affected" the applicant has recorded the answer as 'No', he now cannot make a request that his candidature can be considered as a Project Affected Person. Secondly, on the date on which the applicant had made an application, admittedly he was not possessing the

certificate as project affected person. Subsequently the applicant has secured the said certificate. It need not be stated that the status of the applicant as on the date of filling in the application form only will be considered and even though subsequently he has secured the certificate of PAP, he cannot now claim the said benefit.

6. For the reasons stated above, the Original Application deserves to be dismissed in limine without issuing notices to the respondents. It is accordingly dismissed summarily without any order as to costs.
