record in respect of the transfer effected of the applicant. Vide the

impugned order the applicant has been transferred from his present

post i.e. of Deputy Director, Town Planning, Development Plan,

Special Unit, Aurangabad Municipal Corporation to the vacant post of

Deputy Director, Town Planning, Maitri Kaksha, Maharashtra State

Small Development Corporation, Mumbai.

3. The applicant was appointed on the present post w.e.f.

9.8.2021. Before coming to Aurangabad the

applicant was working as Deputy Director, Town Planning Development Land, Special Unit, Nanded Waghala Municipal Corporation. Vide G.R. dated 2.8.2021 it was resolved to shift the entire said unit to Aurangabad to work on the development plan of the Aurangabad Municipal Corporation. As is revealing from the documents on record in the said special unit the applicant is head of the said unit and there are certain 8 officers and some more ministerial staff with him.

4. It is the grievance of the applicant that when most of the work assigned to the said special unit has been completed, he should not have been transferred before completing the said task. It is the further grievance of the applicant that while transferring him from the existing posting no other officer has been posted in his place. It is the further grievance of the applicant that before transferring the applicant to some other department than his parent department he must have been asked for his willingness for such

transfer. It is the further grievance of the applicant that his wife is also in the Government services and is presently working as a Executive Engineer at Aurangabad in Public Works Department. It is further contended that son of the applicant is in 10<sup>th</sup> standard and his education is likely to be adversely affected because of such midterm transfer of the applicant.

5. Shri Avinash Deshmukh, learned counsel appearing for the applicant submitted that apart from grounds as are mentioned hereinabove it is the main grievance of the applicant that without any cogent reason he has been transferred at the midst of his term at the behest of the political pressure and with only object to bring some person in good books of the political person at whose behest applicant has been transferred. The applicant, in the circumstances, at the time of filing the present application had also prayed for an interim relief thereby temporarily staying the effect and operation of the impugned order of transfer, as well as, relieving order.

- 6. The record shows that the Government has filed Caveat in the present matter and having regard to the Caveat so filed, the then learned Member (J) find it appropriate to give an opportunity to the respondents to file on record their affidavit in reply and the matter was thereafter kept for further consideration today i.e. 16.12.2022. Today, when the matter is taken up for further consideration the learned C.P.O. has placed on record relevant documents. The learned C.P.O. has also placed on record order dated 9.12.2022 whereby one Shri Kharwadkar S.S. has been given posting in place of the applicant. The respondents have also placed on record the document evidencing that Shri Kharwadkar had taken over the charge of the subject post on 13.12.2022.
- 7. The request so made by the applicant seeking interim relief as noted hereinabove has been strongly opposed by the respondents. Learned C.P.O. pointed out that transfer is an incident of service in the service career of any Government employee and if transfer is made by following prescribed procedure the only option

with the Government servant is to obey the said order. The learned P.O. pointed out that Hon'ble Minister Shri Sandipanrao Bhumare, Minister for Employment Guarantee Scheme and Horticulture had made a written request for the transfer of the applicant and the said request was considered and the Civil Services Board recommended the transfer of the applicant and accordingly the impugned order has The learned P.O. pointed out that the highest been passed. competent authority i.e. Hon'ble the Chief Minister has also accorded approval for the transfer of the present applicant. It is submitted that when the Civil Services Board, which is the competent body to recommend the transfers, has recommended the transfer of the applicant and the highest competent authority has accorded approval for such transfer, there cannot be any prima facie case in favour of the applicant as has been claimed by him and in the circumstances, request has been made for rejection of the prayer for interim relief.

- 8. As has been submitted by Shri Deshmukh, learned counsel appearing for the applicant, the midterm transfer of the applicant is politically motivated and has been passed only at the instance of the Hon'ble Minister. Learned counsel submitted that without having just and sufficient reason to transfer the applicant amounts to his victimization. Additionally, it has also been contended that the task which was assigned to the applicant and his team is in the process of finalization and as such, in no sense a transfer of the applicant can be said to be for bona-fide reasons or for any just administrative ground. Some personal difficulties are also put-forth by the applicant, first that, his wife is also posted at Aurangabad and that his son is in the 10th standard.
- 9. Learned counsel for the applicant further submitted that with the only intention that the prayer for interim relief gets frustrated, the posting is shown to have been made of one Shri S.S. Kharwadkar on 9.12.2022 itself giving him additional charge of the post, which the applicant was holding. Learned counsel pointed out that

when the matter was heard by the Tribunal on 13.12.2022, as recorded by this Tribunal in paragraph 7 of the said order, learned CPO could not provide any concrete information to the Tribunal about handing over of the charge of the post held by the applicant to any other officer. Learned counsel pointed out that on that day no information was provided to the Tribunal by the learned CPO that some officer by name Shri Kharwadkar has been given additional charge of the post of the present applicant. Learned counsel submitted that this fact clearly demonstrates that the appointment issued in the name of Shri Kharwadkar is subsequently issued showing the date of issuance of said order as 9.12.2022, though the said order does not seem to have been issued on the said date. Learned counsel submitted that in the impugned order there is absolutely no reference of posting of any other person on the post of applicant and in the circumstances, prayer was made to grant temporary stay to the effect and operation of the order of transfer and the order of relieving the applicant from the existing post.

- 10. Learned counsel further submitted that till this date charge has not been handed over by the applicant to any other officer, in the manner, the same has to be handed over. Learned counsel further submitted that today, though the information is given to the Tribunal as about the appointment of Shri Kharwadkar and further that said Shri Kharwadkar has taken the charge on 13.12.2022, there was no communication from the side of Shri Kharwadkar to the present applicant that on which day he will be resuming the charge. Learned counsel pointed out that respondents have failed in establishing that the procedure as prescribed under the rules for taking and handing over the charge has been followed in the present matter and, as such, the applicant has to be held to be incharge of the subject post. Learned counsel in the circumstances has insisted for grant of interim relief in favour of the applicant.
- 11. Learned CPO taking me through the documents placed on record by the respondents submitted that the transfer of the applicant has been ordered after having complied with all necessary requirements as prescribed

under Transfer Act, 2005. Learned CPO pointed out that the Civil Services Board (for short CSB) which is the competent body, recommended for the transfer of the applicant and the proposal of transfer has been ultimately approved by the highest authority i.e. the Hon'ble Chief Minister of the State. Learned CPO pointed out that on 9.12.2022 itself further order was passed by the State Government thereby giving additional charge of the post held by the applicant to one Shri Kharwadkar. Learned CPO further submitted that Shri Kharwadkar. has already taken over the charge of the subject post on 13.12.2022 and as such, the prayers made by the applicant seeking stay to the order of his transfer and the order whereby he has been relieved, both have become infructuous. Learned CPO, in the circumstances, has prayed for rejection of the prayer of interim relief and to fix the matter for final hearing by giving due opportunity to the respondents to file their affidavit in reply.

12. I have duly considered the submissions advanced by Shri Deshmukh, learned counsel appearing for the applicant and Shri M.S. Mahajan, learned CPO appearing

for the respondents. I have also gone through the documents which are made available for perusal of the Tribunal. It is the case of the applicant that his alleged transfer is under the political pressure and he has been victimized by transferring from the existing post in the midst of his term without there being any just and sufficient reason therefor. It is also assertive contention of the applicant in his OA that he has not handed over the charge of his post to anybody and he is still holding the charge.

13. As against it, according to the respondents, the applicant has been transferred by strictly following the procedure laid down for such transfer. It has also been contended that in view of the fact the transfer has been recommended by the CSB and approved by the highest competent authority of the State i.e. the Hon'ble Chief Minister, there is no scope for considering the request of the applicant for grant of interim relief as has been prayed by him and more particularly when one Shri Kharwadkar has already taken over the charge of his post.

14. Though the respondents have placed on record copy of the order whereby Shri Kharwadkar has been directed to take additional charge of the subject post, and the said order is shown to have been issued on 9.12.2022, the objection as has been raised on behalf of the applicant that the order concerned was subsequently issued cannot be outrightly rejected. The Tribunal had heard learned counsel for the applicant, as well as, learned CPO for the respondents on 13.12.2022. On the said date, as has been recorded in the order passed by this Tribunal on that day, no such information was provided that Shri Kharwadkar has been given additional charge of the said post and that he has taken over additional charge of the said post before office hours of 13.12.2022. Had it been the fact that Shri Kharwadkar was given additional charge vide order dated 9.12.2022 and had it been further true that said Shri Kharwadkar took over the additional charge of the said post on 13.12.2022 that too before office hours, it is most unlikely that learned CPO would submit that there was no information with him.

15. Insofar as the transfer order of the applicant is concerned, the documents on record clearly reveal that it has been ordered on request/complaint made by Hon'ble Minister for Employment Guarantee Shri Sandipan In and Horticulture. namely, Bhumre. the recommendations of the CSB also there is clear reference of the letter given by Hon'ble Minister. In the proposal which was placed before the Hon'ble Chief Minister for his approval also there is reference of letter of Shri Sandipan Bhumre dated 2.11.2022. When the CSB, which is the competent body for recommending the transfer/midterm transfer of the Government employee, and when there appears approval to such transfer by the highest competent authority in the State i.e. the Hon'ble Chief Minister, prima-facie, it may appear that appropriate procedure has been followed in ordering the transfer of the applicant. However, after having gone through the contents of the letter dated 2.11.2022, written by Hon'ble Minister to the Hon'ble Chief Minister, as well as, the contents of recommendations made by CSB and the contents of the proposal which was put-forth before the Hon'ble Chief Minister for his

approval, it is apparently revealed that, in none of the aforesaid documents any reason much less any specific reason has been assigned which may justify the order of transfer issued on 9.12.2022, which has been impugned in the present OA.

16. I deem it appropriate to reproduce hereinbelow the entire contents of the letter written by the Hon'ble Minister to the Hon'ble Chief Minister, which reads thus:-

छ. संभाजी नगर महापालिकेचा विकास आराखडा प्रलंबित आहे. सदर आराखडा प्रलंबित असल्यामुळे संभाजीनगर शहराचा विकास खुंटला आहे. पुर्वी शहर विकास आराखडा तयार करताना प्रशासनाने मोठया प्रमाणात चुका केल्या. ही बाब विचारात घेऊन माननीय सर्वोच्च न्यायालयाने प्रस्तावित आराखडा रद्द केला आहे. यामुळे प्रशासनाची नाचक्की झालेली आहे. नव्याने हा आराखडा होणे प्रस्तावित आहे. उप संचालक, नगर रचना विकास योजना, छ. संभाजीनगर महानगर पालिका यांच्या अंतर्गत शहर विकास आराखडा बनवण्याचे काम चालू आहे.

श्री. मोहम्मदरना खान, उप संचालक, नगर रचना विकास योजना, महानगर पालिका छ. संभाजी नगर यांची या पदावरुन तातडीने बदली करणे आवश्यक आहे. तसेच पदाचा अतिरिक्त कार्यभार श्री. सु.सु. खरवडकर, सहाय्यक संचालक, नगर रचना विकास योजना, छ. संभाजीनगर यांच्याकडे देण्या बाबत उचित कार्यवाही व्हावी विनंती.

- 17. The CSB's recommendations as are recorded while effecting transfer of the applicant are reproduced separately in the end of the order as **Appendix-A**:
- 18. The proposal which was put before the Hon'ble Chief Minister and which has been approved by Hon'ble Chief Minister is the repetition of the contents which are in the recommendations of the CSB. The contents as aforesaid would reveal that without assigning any reason, the applicant has been shifted from his existing post and is transferred to a Corporation under the control of the State Government. Had there been any whisper about any specific complaint against the applicant in respect of the work assigned to him or had there been such allegation that he is delaying the preparation of Development Plan it could have been said that there was some reason to consider the request made by the Hon'ble Minister. On the contrary, as has been submitted on behalf of the applicant, the task assigned to the team under his headship has been substantially completed and it is at the stage of its finalization. In the letter of Hon'ble Minister and the

proposal placed before the Hon'ble Chief Minister, there is certainly a reference of the previous development plan which was canceled by the Hon'ble Supreme Court, but there is nothing as about the work being presently carried out by the applicant and his team.

19. Documents on record do not reveal any fault on the part of the applicant or any short comings in the work being performed by the applicant. In the circumstances, it appears that, the only reason for transfer of the present applicant is the insistence of the Hon'ble Minister, namely Shri Sandipan Bhumre. The Hon'ble Bombay High Court in the judgment delivered in the case of Balasaheb Vitthalrao Tidke Vs. State of Maharashtra & Anr., W.P. No. 8987/2018 decided on 12.12.2018 has specifically dealt with the issue as about the transfers effected on the recommendations of the political leaders under pressure of political parties or any Hon'ble Minister, who is not part of the process of such transfer. In the said matter, affidavit was filed by the then Chief Secretary of the State on behalf of the State, which is reproduced in the order passed in the said WP, which reads thus:-

- "1. I submit that I am filing the present Affidavit for the limited purpose of stating that the process of transfer at the level of the Government will not be influenced by any recommendations made by any political leaders, members of political parties or any Hon'ble Ministers who are not part of the process of transfers.
- 2. I submit that all authorities who are competent to effect the transfers will be advised to strictly follow the provisions of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 while issuing transfer order."

On the basis of undertaking so given following order was passed by the

Division Bench of Hon'ble High Court:-

- "4. Hence, we pass the following order:
- (i) The writ petition is disposed of as withdrawn;
- (ii) The statements made in paras-1 and 2 of Affidavit of Mr. Dinesh Kumar Jain, Chief Secretary of the State Rane 6/6 WP-8987-2018 (SR.4) 12.12.2018 Government dated 12th December, 2018 are accepted as statements made on behalf of the State Government and the undertakings given by the State Government;
- (iii) We hope and trust that the statements made in the Affidavit of Mr. Dinesh Kumar Jain are made known to all concerned authorities exercising powers under the said Act of 2005 to avoid any attempt of political influence in the process of transfer;

- (iv) Though the Petition is disposed of, the protection granted to Shri. ShripatShinde under Clause-11 of the order dated 2nd November, 2018 stands;
- (v) There shall be no order as to costs."
- 20. From the documents on record, *prima facie*, it appears that the applicant has been transferred only at the instance of the Employment Guarantee and Horticulture Minister and except that there is no other reason. Perusal of letter dated 2.11.2022 written by Hon'ble Minister to the Hon'ble Chief Minister reveals that Hon'ble Minister has recommended the name of Shri Kharwadkar for giving him additional charge of the subject post. It is, thus, evident that the transfer has not been made on administrative exigency, but to adjust and accommodate the officer whose name has been recommended by the Hon'ble Minister. In his letter though the Hon'ble Minister has stated that the applicant needs to be, "urgently" transferred, none of the documents placed on record today reveal any such reason which would justify the need of urgent transfer of the applicant from the subject post. To find out

whether the transfer is made for real administrative exigency, many times Courts/Tribunals are required to pierce the veil of the transfer order. If the findings reveal a nexus with the administrative necessity, the exercise of power has to be upheld. If however, operative reasons have no such nexus as is appearing in the present case, such order of transfer has to be held a mala fide use of power. Such decision can certainly be interfered with, when *prima facie* it appears that the impugned order of transfer is an arbitrary exercise of power. Despite a statement made on affidavit in the aforesaid matter that an attempt of political influence in the process of transfer would be avoided, in the present matter such political influence is apparently visible. The applicant has, therefore, certainly made out a *prima facie* case for grant of interim relief in his favour.

21. The next question falls for my consideration is whether the order of transfer can be stayed may be temporarily when Shri Kharwadkar is reported to have resumed the additional charge of the post held by the

applicant? I see no difficulty in passing such order when the impugned order is prima-facie noticed to be an arbitrary and mala fide exercise of power. Since there is no complaint or allegation in regard to the competence and/or efficiency of the applicant, in fact it would be in the interest of people of Aurangabad that the applicant is permitted to continue the work specially assigned to him and complete the task given to him. Shri Kharwadkar has been otherwise also given additional charge of this post. His said order can be kept in abeyance or may be for the time being withdrawn by the Government.

22. In the result, the following order is passed:-

#### ORDER

(i) The order of transfer of the applicant dated 9.12.2022 issued by respondent No. 1 and the order dated 9.12.2022 issued by respondent No. 3, relieving the applicant from the post of Deputy Director, Town Planning Development Plan, Special Unit, are temporarily stayed until further orders. Consequently,

the respondents are directed to allow the applicant to perform his

duties on the subject post till then by passing further necessary

orders thereby withdrawing the additional charge given of the said

post to Shri S.S. Kharwadkar.

(ii) The respondents shall file the affidavit in reply on the next date

without fail.

(iii) The matter may be finally heard at the stage of admission itself.
