- 2. There is a delay of 06 years and 03 days caused in filing the accompanying Original Application.
- 3. Learned counsel for the applicant submits that in fact there is a delay of 01 years and 10 months caused in the filing the accompanying Original Application, however the office has counted the said delay from the date of acquittal and therefore, condonation of delay of 06 years and 03 days is sought.
- 4. Learned counsel for the applicant submits that the applicant was appointed as Police Constable in Aurangabad city after following due selection process on 25.12.1991. In the year 2007, the applicant was posted at Jawahar Nagar Police Station,

Aurangabad. Further on the basis of complaint filed against him, Crime No. 3049/2007 for the offences punishable under sections 7, 12, 13(1)(d) with 13(2) of the Prevention of Corruption Act came to be registered against the applicant with City Chowk Police Station, Aurangabad. Consequently, applicant was suspended by respondent No. 3 i.e. the Deputy Commissioner of Police, (Headquarter), Aurangabad with effect from the arrest i.e. on 28.09.2007. On 13.08.2009, the respondent No. 1 had issued an order to respondent No. 2 with a direction to reinstate the applicant and by order dated 02.09.2009; the respondent No. 3 has reinstated the applicant in service. By judgment and order dated 30.01.2016, the Additional Sessions Judge, Aurangabad has acquitted the accused in Special Case No. 12/2008 arises out of the said crime. Being aggrieved by the same, the respondent No. 2 has filed appeal before Hon'ble High Court of Bombay, Bench at Aurangabad bearing No. 11/2018, which is still pending for admission. On 31.10.2019, the applicant got retired.

5. Learned counsel for the applicant submits that 18.12.2019 the applicant applied before the respondent authorities and prayed to treat the suspension period of 28.09.2007 to 02.02.2009 as regular duty period by filing representation to that effect. On 05.10.2020, the respondent authorities have not decided the said representation, but only informed to the applicant that final decision about the same would be taken only after the appeal against the acquittal preferred by the respondents is decided by the Hon'ble High Court of Bombay, Bench at Aurangabad. Learned counsel submits that there is recurring cause of action as long the said issue finally not decided by the department and there is no delay as such. Even if the delay to that extent is considered from the date of said order dated 05.10.2020 (Annexure A-8 of the O.A.), there is no inaction on part of the applicant nor there is an intentional or deliberate delay as such. Learned counsel submits that the application seeking condonation of delay deserves to be allowed.

- 6. Learned Presenting Officer has strongly resisted the application on the ground that there is inordinate delav caused in filing an the accompanying Original Application. Learned P.O. fairly accepted that the delay is required to be counted from the date of communication i.e. on 05.10.2020, on which the department has informed to the applicant that the decision about the period of suspension would be taken only after pending appeal against the acquittal is decided by the Hon'ble High Court of Bombay, Bench Aurangabad. Learned counsel submits that the applicant has not satisfactorily explained even the said delay and as such, this application is having no substance is liable to be dismissed.
- 7. Even though the applicant is retired, the department has not decided the period of suspension as to whether the said period is to be treated as duty period or not under the pretext that the appeal against the acquittal is pending before the Hon'ble High Court of Bombay, Bench at Aurangabad. Admittedly, no departmental enquiry

has been initiated against the applicant. In view of the same, there is recurring cause of action and the delay is on the part of department to keep the representation of the applicant pending. There is no inaction on part of the applicant nor there is intentional or deliberate delay in any form. Thus, considering the entire aspect of the case, I am inclined to condone the delay, if any caused in filing the accompanying Original Application. Hence, the following order:-

### ORDER

- (i) The M.A. No. 318/2023 is hereby allowed.
- (ii) The delay of 06 years and 03 days, if any caused in filing the accompanying O.A. is hereby condoned.
- (iii) Accompanying O.A. be registered and numbered in accordance with law.

- 3. All these applicants are holding qualification as M.Sc. (Medical Bio-chemistry). It is the contention of all these applicants that they are holding the requisite qualification as prescribed in the corrigendum dated 11.12.2023 issued to the

advertisement Nos. 135/2023 to 262/2023 issued Our attention was invited to the on 05.12.2023. qualifications as are prescribed in the corrigendum for the post of Assistant Professor in Bio-chemistry. It has been argued that M.Sc. (Medical Biochemistry) is held the requisite qualification to apply for the post of Assistant Professor in Bio-chemistry. In view of the corrigendum issued on 11.12.2023, according to the learned counsel appearing for the applicants, MPSC, should not have held the applicants ineligible, insofar as educational qualification is concerned. In the circumstances, the prayer has been made seeking directions against the MPSC to call all these applicants for interview subject to outcome of the present O.A. It is pointed out that the interviews are scheduled on 20.02.2024.

4. Learned Presenting Officer has tendered across the bar communication dated 16.02.2024 received to the office of C.P.O. As mentioned in the said communication the candidates holding the qualification of M.Sc. in the relevant subject are mandatorily required to have Ph.D. in that subject

and only such candidates are to be held eligible for the post of Assistant Professor in Bio-chemistry. Learned P.O. in the circumstances has prayed for rejecting the prayer for interim relief.

- 5. Learned counsel appearing for the applicants submitted that in the communication, which is tendered across the bar today, the M.P.S.C. has not clarified whether in the corrigendum issued on 11.12.2023 the qualification mentioned as M.Sc. (Medical Bio-chemistry) has been wrongly included or otherwise.
- 6. The present matters were heard for some times yesterday and were adjourned till today only for the purpose of explanation from the MPSC as about the qualification of M.Sc. (Medical Biochemistry) mentioned in the corrigendum dated 11.12.2023 as required educational qualification for the post of Assistant Professor in Biochemistry. The MPSC however has not given any such explanation. In the communication received from the MPSC, however, it is emphasized that the candidates holding

qualification of M.Sc. in the relevant subject should mandatorily require to hold the degree of Ph.D. also.

7. We have carefully perused the corrigendum dated 11.12.2023 issued by the MPSC to the advertisements no. 135/2023 to 262/2023 issued on 5.12.2023. It is noticed that for none of the subjects i.e. Anatomy, Physiology, Pharmacology and Microbiology the bare degree of M.Sc. in that particular subject is provided as the required educational qualification for the post of Assistant Professor in the said subject. Along with degree of M.Sc., the candidate is supposed to hold either the degree of M.B.B.S. or DSC or Ph.D. etc. Sole degree of M.Sc. (Medical Biochemistry) is provided only for the subject of Biochemistry. In the circumstances, only on the basis of Corrigendum dated 11.12.2023, it is difficult to agree with the submissions made on behalf of the applicants that sole degree of M.Sc. (Medical Biochemistry) is the requisite qualification prescribed for the post of Assistant Professor in Biochemistry. As such, it does not appear to us that any case is made out even prima-facie to accept the request of the applicants for grant of interim relief as

prayed by them. The issue raised by the applicants however deserves consideration. In the circumstances, we deem it appropriate to clarify that if the appointments are made during the pendency of the present O.As., all such appointments shall be subject to outcome of the O.As.

- 2. In both the OAs since the grievance raised and the prayers made are identical, we have heard common arguments in both these OAs and deem it appropriate to decide the same by common reasoning.
- 3. Learned counsel for the applicants submitted that some similarly situated other employees having

identical grievance had filed the WPs before the Aurangabad Bench of the Hon'ble Bombay High Court and in the said WPs the Hon'ble High Court has passed a common order on 24.11.2021. The applicants have produced on record copy of the said order. Learned counsel taking us through the order passed by the Hon'ble High Court in the said group of WPs prayed for similar orders in the present OAs.

- 4. Learned Chief Presenting Officer appearing for the respondents in the present matters did not oppose for passing such order.
- 5. We have perused the order passed by the Hon'ble High Court referred to and relied upon by the learned counsel appearing for the applicants passed in W.P. No. 5252/2020 with connected WPs on 24.11.2021. The petitioners before the Hon'ble High Court were appointed as ANM/Health Worker under the programme of Reproduction and Child Health Project (RCH). Majority of the petitioners were appointed prior to ten years. Some of them were appointed for a lesser period also. It was the contention of the said petitioners that they were appointed after passing the written examination, and

conduct of interview pursuant to the advertisement. The medical verification was also done. submitted on behalf of the petitioners that the RCH project was continuing. It was also submitted that the said project was funded by the Central Government to some extent and the employees employed thereunder were paid consolidated amount of salary every month. It was argued on behalf of the Government that the said petitioners were not appointed against the sanctioned post of Zilla Parisahd or the State Government and appointed under the project on contract basis and, as such, cannot be regularized. The Hon'ble High Court after having considered the submissions made on behalf of the petitioners and the respondents therein passed the following order: -

"11. In the light of that, we direct the State Government to consider the cases of the petitioners for regularization either on the posts they are working under the RCH or some other posts under the State Government considering the length of service. The State Government can also fix the cutoff date viz. that the persons working for a minimum period of particular years may be considered for regularization.

- 12. The State Government may take decision upon the aforesaid aspect i.e. the regularization of the services of the petitioners as discussed above on its own merits, expeditiously and preferably within a period of six (06) months from today. Depending upon the decision taken by the State Government, the parties may take appropriate steps.
- 13. With the aforesaid observations and directions, the writ petitions stand disposed of. No costs."
- 6. In light of the order passed by the Hon'ble High Court as aforesaid when we examined the cases of the present applicants, it is noticed that the applicants stand at par with the petitioners in the aforesaid WPs decided by the Hon'ble High Court. Both the applicants have been selected after passing the written examination, conduct of interview pursuant to the advertisement. Both appear to be working for more than ten years. Their entry in service cannot be said to be a backdoor entry. In the circumstances, it appears to us that the applicants also deserve to be granted the same relief as has been granted by the Hon'ble High Court in favour of the petitioners in the aforesaid writ petitions.

It is the contention of the applicant that the respondent no. 02 did not consider the candidature of the applicant on the ground that the experience certificate was not submitted by the present applicant in the format as was directed to be submitted in the advertisement.

3. Learned counsel for the applicant submitted that respondent no. 02 in its communication dated 07.06.2023 has candidly admitted that the applicant is holding the experience for the advertised post as prescribed in the advertisement, however, since the certificate is not in the proper format, the required aspects are not being cleared by the applicant. Learned counsel submitted that the applicant was holding the required experience even on the date of filing the application, however, the relevant certificates as were required could not be submitted by the applicant at the relevant time. Learned counsel submitted that insofar as this aspect is concerned, the M.P.S.C. has always given an opportunity to the candidates to rectify such mistakes and submit the certificates in the proper Learned counsel submitted that the format. applicant must have been given the same treatment by respondent no. 02. Learned counsel submitted that even otherwise there seems no candidate eligible to be appointed, since all the candidates, who have, applied for the said post, have been held ineligible by the respondents. In the circumstances, prayer has been made by the applicant in the

present application seeking direction against the respondents to reconsider the case of the applicant for his appointment to the post of Anesthetist, if he is fulfilling all the norms as required.

- 4. Respondents have failed in filing affidavit in reply and hence the matter has been heard without their reply. Learned Presenting Officer submitted that the candidates are under an obligation to fully comply with the conditions incorporated in the advertisement while filling in the application, since the applicant failed in discharging said obligation, now he cannot make such request for reconsidering his application. Learned P.O., therefore, prayed for rejection of the Original Application.
- 5. We have duly considered the submissions advanced on behalf of the applicant, as well as, the respondents. We have also gone through the documents placed on record. From the documents it is quite clear that none of the candidates, who had applied for the subject post, is held eligible for to be considered for such appointment. Insofar as the present applicant is concerned, the communication

at page 28 of the paper book i.e. letter received to the applicant dated 7.6.2023 from the M.P.S.C. reveals that though the M.P.S.C. has admitted that the applicant possesses the requisite experience, he has not held him eligible for want of his experience certificate in the proper format. If that be so, it appears to us that the applicant must be given an opportunity to submit a document insofar as the experience part is concerned and if he holds the experience as required, further process can be undertaken by respondent no. 02.

- 6. Documents placed on record in regard to some other recruitment processes reveal that respondent no. 02 has given an opportunity to the candidates to bring the requisite experience certificates at the time of document verification. It appears to us that same procedure could have been adopted in the present recruitment also.
- 7. In the circumstances, the present Original Application can be disposed of by giving directions to respondent no. 02 to give an opportunity to the applicant to submit the experience certificate in the

prescribed format and if respondent no. 02 on scrutiny of said document finds that the applicant is holding the required experience, further process in pursuance of the advertisement No. 124/2022 may be carried out. It is clarified that, the applications of the remaining candidates, if have been rejected on the same ground, there shall not be any impediment for calling such candidates also for rectifying the said mistake and opportunity be given to all of them though they have not approached the Tribunal. We are informed that there is serious shortage of Medical Officers in the Government Hospitals, as well as, Medical Colleges and also in the ESIS Hospitals. If this be so, the respondents shall not be too technical in processing the applications. While saying so we do not mean that the essential eligibility criteria is be overlooked to compromised. Those aspects are to be scrupulously looked into. However, only on the ground that the certificate is not submitted in the prescribed format, the candidates shall not be held ineligible and such mistakes can be get rectified by the candidates Of course, this course is also to be concerned. adopted in the exceptional circumstances.

Heard Shri V.R. Jain, learned counsel for the applicant and Mrs. Deepali S. Deshpande, learned Chief Presenting Officer for the respondent authorities.

- 2. The applicant has filed the present application seeking direction against respondent No. 3 i.e. the District Malaria Officer, Aurangabad to issue order of appointment to the applicant on the post of Multipurpose Health Worker (Malaria) from 40% quota reserved for fresh candidates. Since the delay has occasioned in filing the O.A. the applicant has filed the present Misc. Application seeking condonation of delay, which has occurred in filing O.A.
- 3. In the M.A. it is the contention of the applicant that though the applicant passed written examination and he was only one candidate for the

post of Multipurpose Health Worker (Malaria) from OBC category, the respondents did communicate to the applicant why he has not been selected. It is the further contention of the applicant that the respondents published the first selection list, wherein the name of the applicant was not The respondents then published second included. and third selection lists, however, in the said lists also his name was not there. As contended in the application the third list was published in the year 2019. It is the further contention of the applicant that the applicant was not intimated or informed the reasons for not selecting him and, hence, did not approach the Court or Tribunal. It is further contended that ultimately in the year 2021, he filed W.P. before the Hon'ble Bombay High Court Bench at Aurangabad. It is his further contention that on 25<sup>th</sup> October, 2021, the Hon'ble High Court disposed of the W.P. by giving liberty to the applicant to approach this Tribunal. It is further contended that in March, 2020 the Central Government, as well as, the State Government had declared lockdown due to COVID-19 and in such circumstances the applicant

could not approach to the Court and, therefore, the delay has been caused in filing the O.A. According to the applicant, there is delay of 03 years, 04 months and 02 days. Learned counsel appearing for the applicant submitted that the delay caused in filing O.A. is unintentional and for bona-fide reasons. He, therefore, prayed for condoning the delay.

- 4. The respondents have filed affidavit in reply opposing the contentions raised in the application. Learned Presenting Officer submitted that the applicant has failed in making out the sufficient cause for condoning the delay and, therefore, prayed for rejecting the application.
- 5. We have duly considered the submissions behalf of the on applicant and respondents. We have also perused the contents of the M.A. as well as O.A. and the documents placed on record in the O.A. The documents on record reveal that the advertisement was issued on 21.01.2016. The written examination was held on 8th January, 2017. The applicant was called for

counseling document verification and on 20.08.2017. Though the applicant has taken a plea that 03 selection lists were published and third selection list was published in the year 2019, nothing has been produced by the applicant in support of his said contention. On the contrary, the documents filed on record reveal that the applicant was selected in the category of OBC (part time) and was, therefore, called for counseling. Though the applicant has raised another plea that he was never communicated as to why he has not been selected, in the O.A. it is disclosed that he was not selected as he was not possessing 90 days' experience certificate as Seasonal Spraying Worker. In the advertisement there was a specific contention that for appointment from the quota of part time employees the candidate concerned was required to possess the certificate of experience of having worked for 90 days as Malaria Spraying Worker. It appears that since the applicant did not submit the requisite certificate he could not be selected. The applicant thus has not disclosed the facts correctly in the M.A.

6. Secondly, from the documents it is quite evident that the cause of action to approach the

Tribunal had arisen in the year 2017 itself or at the most in the beginning of the year 2018. However, the applicant did not take any prompt steps to ventilate his grievance. Two reasons are stated by the applicant to justify the delay occasioned in approaching this Tribunal. First that he was awaiting communication from the respondents and second that in the meanwhile because of CORONA pandemic he could not approach the Tribunal. The first reason as has been assigned is not genuine. The list of selected candidates was published and the applicant was also called for the document verification on 20.08.2017.

7. From the averments taken in the O.A. it is quite evident that the applicant was quite aware of the fact that he was not selected as he failed in producing on record the experience certificate. Thus the said reason cannot be accepted. The reason as about the CORONA Pandemic is also difficult to be accepted for the reason that the period of CORONA pandemic started in March, 2020. The applicant has failed in explaining the period in between August, 2017 to March, 2020. In the matters of

recruitment the candidates are supposed to be more diligent. The recruitment process started in the year 2017, must have been concluded. The applicant has also not produced on record any evidence to show that the posts, which were advertised vide advertisement dated 21.01.2016, are still vacant.

- 8. It is further noticed that the applicant had applied for the subject post claiming the benefit of being seasonal worker as Malaria Spraying Worker through that quota and he seems to have been declared ineligible or has not been considered for not having the requisite experience of 90 days' work as a Malaria Spraying Worker, whereas in the O.A. request is made for the appointment against the seat reserved for direct recruit i.e. fresher, which may not be permissible.
- 9. For all above reasons and more particularly for failure on the part of the applicant in making out any sufficient cause for condoning the delay, the application deserves to be rejected and is accordingly rejected, however, without any order as to costs.
