However, recently decision is delivered by the Hon'ble Tribunal in identical case i.e. O.A.No.903 of 2017 on 2.2.2018 in the matter of Shri S.P. Ranadive may also kindly be taken into consideration by this Hon'ble Tribunal while adjudicating this case."

(quoted from para no.11, page no.79 of the O.A.)

5. The reply in the affidavit filed on behalf of Director General of Police quoted in foregoing para is worded in very polite language but inadequately and skeptically.

- 6. Efforts are made to distinguish the judgment of Kadam's case, though prima facie the judgment relied upon by the Respondent arises is totally different scenario.
- 7. Therefore, learned C.P.O. for the Respondents was called to state whether D.G. should be directed to file his own affidavit.
- 8. Learned C.P.O. for the Respondents states that an affidavit by Additional Director General (Establishment) will suffice.
- 9. In the circumstances, Additional Director General, Establishment is directed to explain as to how Applicant's case is not governed by the Division Bench judgment of this Tribunal in O.A.No.992 of 2014 (supra).
- 10. Affidavit be filed 10 days before the next date.
- 11. S.O. to 31.07.2018.
