2. The applicant had applied for the post of Associate Professor in Surgery available at two places at Government Medical College at Sindhudurg and the Government Medical College at Nandurbar. It is the grievance of the applicant that though for both the posts one common interview was taken, the marks received in the said interviews are differently shown in the merit list published by the Maharashtra Public Service Commission for the said two posts. Learned counsel submits that in the list prepared for the appointment to the post available at Sindhudurg he has been shown to have received 63 marks and he is placed at Sr. No. 2 in the merit list. Insofar as Nandurbar is concerned he has been shown to have received 61 marks and is placed at 2nd number in the merit list.

3. It is further submitted that when the interview was taken by the same committee only once there cannot be different marks, as result of the said interview. Learned

counsel submits that the applicant belongs to S.C. category and post at Nandurbar is earmarked for S.C. candidates. According to the applicant, he is entitled to get appointment on the post at Nandurbar. Learned counsel submitted that the respondents are likely to issue the order of appointment to the candidate at Sr. No. 1 namely Patil Milind Vishwas. In the circumstances, the request is made to grant interim relief thereby restraining the respondents from issuing order of appointment as per recommendation made by the M.P.S.C. for Nandurbar, till decision of the present O.A.

3. Learned C.P.O. seeks time to file affidavit in reply and to make submissions after taking instructions from the respondents.

4. After having heard the learned counsel for the applicant we find, *prima facie*, case in favour of the applicant. If it be true that for both the posts only one common interview was taken of the applicant, it *prima facie* appears un-conscionable that performance of the applicant in the said interview will be assessed differently, resulting in giving 61 marks for the post at Nandurbar and 63 marks for the post at Sindhudurg. The apprehension in the mind of the applicant is also not misplaced. In the circumstances, we are inclined to pass the following order:-

ORDER

(1) Issue notice to the respondents, returnable on 28.9.2022.

(2) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(3) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(4) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(5) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

(6) The respondents shall not issue order of appointment insofar as the post at Nandurbar is concerned, until further order.

4. Learned counsel appearing for the applicant submits that the applicant belongs to Scheduled Tribe. He was appointed as Talathi from the category of Scheduled Tribe. Learned counsel submits that the respondents have terminated the services of the applicant w.e.f. 4.11.2015 on the ground that the applicant

failed to file Caste Validity Certificate. Learned counsel submits that by the said time the applicant had already worked with the respondents for about 30 years. Learned counsel further submits that even that time he made attempt to get Caste Validity Certificate but it could not be possible for him. Learned counsel further submits that in the meanwhile period also i.e. during course of the period after termination till filing of the present O.A. the applicant was endeavoring to get Caste Validity Certificate but he failed. Learned counsel further submits that because of the order passed by this Tribunal the Caste of the applicant has now been validated by the concerned Scheduled Tribe Certificate Scrutiny Committee. Learned counsel submits that if the present application is not admitted and rejected only on the ground of delay the applicant may lose the opportunity to prosecute the matter on merits and the service rendered by the applicant for more than 30 years will be in vain. Learned counsel in the circumstances, has prayed for condoning the delay occasioned in filing the accompanying O.A. by the applicant.

5. Learned Presenting Officer has opposed for condoning the delay alleging that the period of 4 years has not been properly justified by the applicant. Learned P.O. further submitted that in fact, during the period of service itself the opportunities were given to the applicant to submit Caste Validity Certificate but he was negligent in not submitting the same. Learned P.O. in the circumstances has prayed for rejecting the delay condonation application.

6. We have considered the submissions advanced by the learned counsel appearing for the applicant and the learned

Presenting Officer appearing for the respondents. We are more concerned with the fact as brought to our notice that the applicant has already served with the respondents for the period of more than 30 years. Had the Caste Validity Certificate, which is now issued in favour of the applicant been issued at the relevant time, the applicant would have certainly entitled for the pensionary benefits. Learned counsel during the course of the arguments also submits that the applicant is not claiming any monetary benefit for the period of the delay, which has occasioned in approaching to this Tribunal. It appears to us that the delay though appears to be of a longer period deserves to be condoned, in the facts and circumstances of the case so that the applicant may get an opportunity to prosecute his matter on merits. We are, therefore, inclined to allow the present application. Hence, the following order: -

ORDER

Application is allowed. Delay caused in filing accompanying O.A. is condoned. The accompanying O.A. be registered in accordance with law.
