Perusal of the record it reveals that the Respondent has included names of the heirs of the some other deceased government servants who were working on the same post i.e. Staff Nurse and on equivalent post drawing the salary in the pay scale of S500 to 9000 in the waiting list of the eligible candidates to be appointed on compassionate ground.

3. But the Applicants request has not been considered by the Respondents for compassionate appointment though his case is similar to that of the above said persons. Not only this but the Respondents have not considered the judgment of the Hon'ble High Court in W.P.No.5440 of 2009 in case of Dinesh s/a Shamrao Sanawane Vs. State of Maharashtra decided on 5.2.2010 wherein the Hon'ble High Court has specifically discussed about the Group 'C' and Group 'B' government employees on the basis of pay scale. Said issue was decided by the Hon'ble High Court again in W.P.No.2465 & 2467 of 2016 in the case of The State of Maharashtra and Others Vs. Geetanjali Kiran Sangale decided on 2.03.2016. This Tribunal has also decided O.A.s in that regard.

4. Therefore it is just to direct the Respondent No.1 to reconsider the cases of the Applicants in the light of the said decisions and take the appropriate decision.

5. If there is any legal impediment, then the Respondent No.1 has to file his short affidavit explaining the same.
