**ORDER**

1. Heard Shri S.K. Hande, the learned Advocate for the Applicant and Smt. K.S. Gaikwad, the learned Presenting Officer for the Respondents.
2. The Applicant has challenged the transfer order dated 25.9.2018 by which she has been transferred from Nanegaon to Natoshi by filing the O.A.
3. The learned Advocate for the Applicant submits that the Respondent No.2, Sub Divisional Officer (S.D.O.), Patan, District Satara has passed the transfer order without following due procedure of law and provision of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Office Duties Act, 2005 (hereinafter will be referred as Transfer Act, 2005). He has submitted that the transfer of the Applicant is mid-term transfer and before issuing the impugned order of transfer, S.D.O. has not placed the case of the Applicant before the Civil Services Board.
4. Learned Advocate for the Applicant has further submitted that the Applicant was involved in the work of Election Commission and the S.D.O. has not taken the permission of the Election Commission for transferring the Applicant. He has submitted that the Applicant has not been relieved from her post, therefore, he prayed to grant stay to the impugned order.

5. Learned P.O. for the Respondents submits that the S.D.O. is the Head of the Department and Competent Authority to transfer the Applicant. She has submitted that there are several complaints against the Applicant and therefore the S.D.O. obtained prior approval for the transfer of the Applicant and thereafter issued impugned order. She has submitted that the case of the Applicant has not been placed before the Civil Services Board and no approval of the Election Commission has been taken for the transfer of the Applicant.

6. On perusal of record, it reveals that the Applicant was engaged in the election programme in view of the communication dated 02.07.2018 but prior approval of the Election Commission, the Applicant has been transferred.

7. Learned P.O. for the Respondents has admitted that the case of the Applicant has not been placed before the Civil Services Board No.3 at the Sub Divisional Level and no prior approval of the higher competent authority for transfer of the Applicant from Nanegaon to Natoshi has been obtained by SDO, Patan.

8. Prima-facie impugned order is in violation of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Office Duties Act, 2005 (Transfer Act, 2005) and therefore, it requires to be stayed.

9. In these circumstances it would be just to stay the execution and operation of impugned order till filing of the reply by the Respondents.

10. Accordingly execution and operation of the impugned order dated 25.9.2018 is stayed till filing of the reply by the Respondents

11. Issue notice before admission returnable on 22.11.2018.

12. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

13. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A.. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

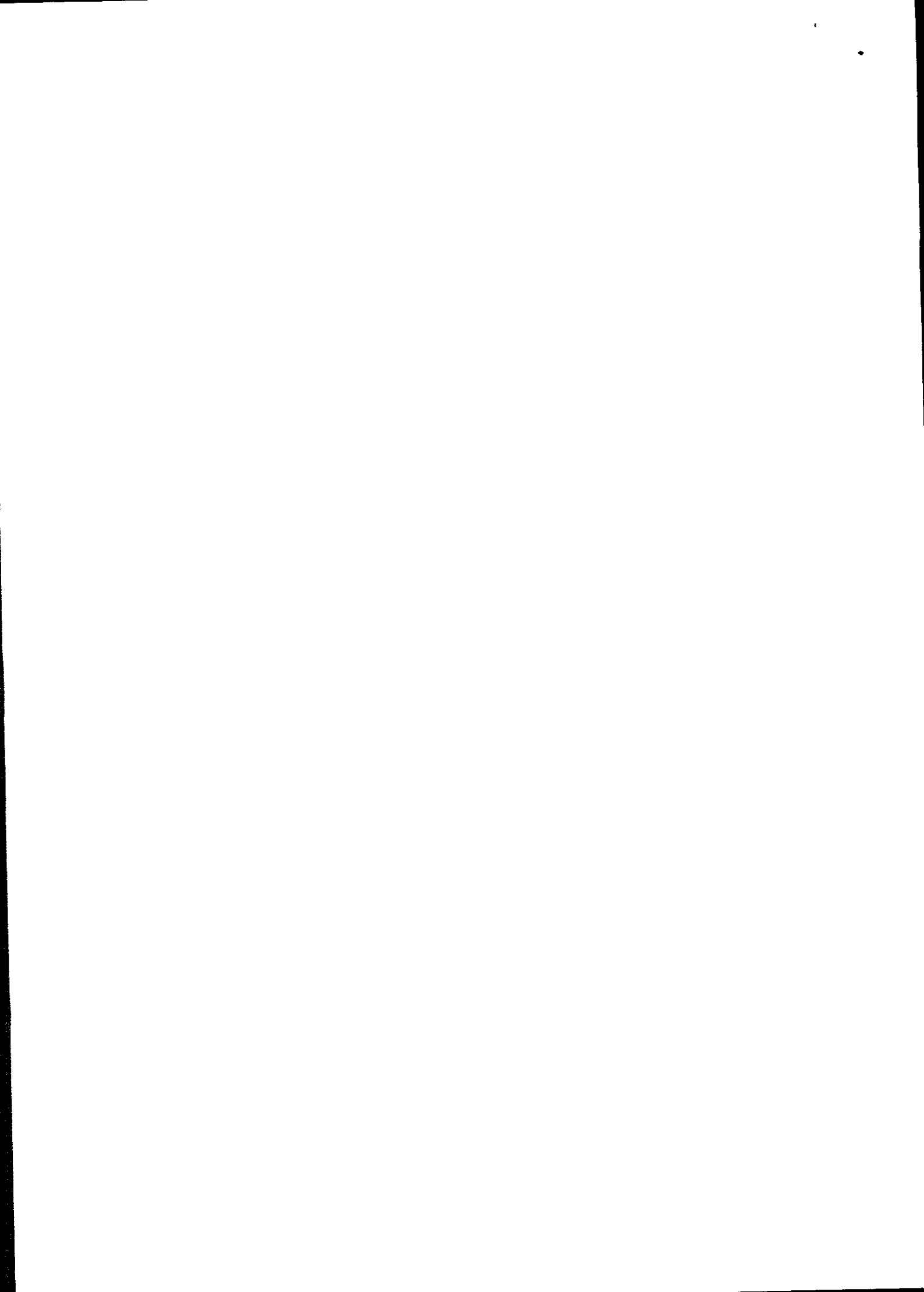
