It is the case of the applicant that she holds the educational qualification and experience for the said post as has been prescribed in the advertisement published in that regard. The learned counsel for the applicant submitted that having regard to the aforesaid facts, name of the applicant was included in the list of 'qualified candidates'. Total 58 candidates were declared as qualified. The learned counsel submitted that the aforesaid list of qualified candidates was published on 17.7.2023. It is further contended that the list of eligible candidates came to be published

thereafter. Simultaneously list of not eligible candidates was also published by the M.P.S.C. Name of the applicant has been shown in the list of not eligible candidates. In the remark column the M.P.S.C. has recorded the reason for declaring the applicant as not eligible. Applicant is declared not eligible on the ground that, she lacks experience of 4 years of working on Class-I post.

3. The learned counsel for the applicant pointed out that since year 2016 the applicant is working on Class-I post and has thus worked on the said post till publication of the advertisement for more than 5 years. Learned counsel pointed out order dated 17.6.2016, whereby the applicant was appointed in the District Hospital Jalna as Medical Officer, Group-A in the Maharashtra Medical and Health Services (MM & HS) Group-A. Learned counsel submitted that the MPSC has wrongly included the name of the applicant in the list of not eligible candidates.

4. Learned counsel pointed out that, interviews are being held of the candidates shown in the list of eligible candidates today and tomorrow i.e. on 17th

and 18th August, 2023. Learned counsel submitted that subject to outcome of the present O.A. respondent no. 3 can be directed to interview the applicant tomorrow i.e. on 18th August, 2023. Learned counsel submitted that the applicant is already there in Mumbai and she can very-well appear in the interview, if the call letter is received to her in that regard from the MPSC. Learned counsel has, therefore, prayed for interim directions as above.

5. Learned Presenting Officer has sought time to file the affidavit in reply. Learned P.O. submitted that without the instructions from the respondents it is not possible for him to make any submission as about the correctness of the facts stated in the application. Learned P.O. has however submitted that the applicant does not seem to have experience of 7 years after acquiring diploma as mentioned in the advertisement. According to the learned P.O., that may be the reason that the applicant has not been held eligible. He has, therefore, prayed for rejecting the prayer for interim relief.

6. I have duly considered the submissions made on behalf of the applicant as well as the State authorities. Though it has been submitted by the learned P.O. that the applicant seems to be not having the requisite experience of 7 years and probably for that reason her name has not been included in the list of eligible candidates, the MPSC has held the applicant not eligible on the only ground that she holds the experience of less than 4 years of working on the Group-I post. In view of the document placed on record by the applicant i.e. G.R. dated 17.6.2016, the applicant *prima-facie* appears to be holding experience of more than 4 years of working on Group-I post. As such, the applicant has made out a *prima facie* case for grant of interim relief in her favour. I, therefore, deem it appropriate to pass the following order: -

2. Despite availing due opportunities in the present matter, the respondents did not file affidavit in reply.

3. In the present matter learned C.P.O. has tendered across the bar communication dated 11.08.2023, whereby the MPSC has informed the present applicant about his representation. Same is taken on record. The MPSC has declined to consider the representation made by the applicant on the ground that life of select list had expired and in such circumstances, request of the applicant cannot be considered.

4. Learned counsel for the applicant strenuously urged for passing interim order, thereby directing

the MPSC to recommend the name of present applicant, since he is going to retire on 31.08.2023. Learned counsel relied upon the judgment delivered by this Tribunal in **O.A. It is the contention of the applicant that the applicant is second highest candidate from NT-B category and in the circumstances, the respondent MPSC must have offered the appointment in favour of the applicant after Nalavade refused to join on the promotional

post. However, as revealing from the reply given by the MPSC to the representation given by the applicant, it appears that since the life of select list had expired as per the MPSC rules, the request was not liable to be considered. After having gone through the said rules and after having considered the judgments relied upon by the learned counsel for the applicant, *prima-facie* it does not appear to me that any case is made out by the applicant for grant of interim relief as has been sought by him. Considering the judgment in the case of **State of J&K and Ors. Sat Pal**(cited supra) even if it is assumed that the select list was alive for next one year after the last recommendation was made, that period expired in 2019. Admittedly, till 2022 even representation was not submitted by the applicant. In the circumstances, no case is made out for grant of interim relief.
