2. The present Original Application is filed challenging the impugned transfer order of the applicant dated 13.02.2023 (Annexure A-4) issued by the respondent No. 1, whereby the applicant is transferred from the post of Dy. Superintendent of Police, Economic Offence Wing / Branch, Nandurbar to the post of Dy. Superintendent of Police, Scheduled Tribe Certificate Scrutiny Committee, Nashik.

3. It is the contention of the applicant that the impugned transfer order is not served upon him and he got the same from website. Learned Advocate for the applicant submitted that till yesterday morning when the O.A. was filed, the applicant was not relieved and further stated that as per the instructions, the applicant is not yet relieved today also and that the applicant has not

handed over the charge of his post and that nobody is posted in his place.

4. According to the applicant, this is mid-term and mid-tenure transfer order passed in contravention of the provisions of Section 22N of the Maharashtra Police Act.

5. The applicant was promoted to the post of Dy. Superintendent of Police as per the Government order dated 02.12.2021 (Annexure A-1). His name is at Sr. No. 11 in the said list and was posted as Dy. Superintendent of Police at Economic Offence Wing / Branch, Nandurbar. He joined on the said post on 20.12.2021 as reflected in joining report dated 21.12.2021 (Annexure A-3) addressed to the respondent No. 4.

6. Learned Presenting Officer submitted that as per the instructions received to him from the concerned respondents, the applicant has been relieved from his present post on 16.02.2023.

7. From the above facts, it is evident that the applicant has been transferred within a period of about 1 year and one month. As per the provisions of Section 22N (1)(a) of the Maharashtra Police Act, the normal tenure for Police Personnel of and above the rank of Deputy Superintendent of Police or Assistant

Commissioner of Police shall be of two years at one place of posting. In view of the same, the impugned transfer order is mid-tenure transfer order. The impugned order is not issued either in the month of April or May and therefore, it is mid-term transfer order.

8. Perusal of the impugned order of transfer order dated 13.02.2023 (Annexure A-4) would show that the transfer order is issued in view of the provisions of Section 22N of the Maharashtra Police Act. In the said provisions, the reasons for mid-tenure transfer order are provided in proviso to sub-section (1) of Section 22N of the Maharashtra Police Act. The impugned transfer order is issued by the competent transferring authority i.e. the respondent No. 1. It also mentions that this order is based on the recommendation of the Police Establishment Board No. 1.

9. In the circumstances as above, in my considered opinion, prima-facie, it cannot said that in any blatant disregard of requisite provisions of Section 22N of the Maharashtra Police Act the impugned transfer order is issued. Moreover, statement on behalf of the respondents is made that the applicant has already been relieved from his present post. In view of the same, I am not inclined to grant any interim relief in favour of the applicant.

10. Issue notices to the respondents, returnable 02.03.2023.

11. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

12. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

13. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

14. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
