3. The three applicants have applied for the said post in response to the said advertisement and they have prayed for similar interim relief therefore, the three

6. Applicants have proposed to amend the original application by introducing news paras no.'s XVIII and XIX in the original application, prayer clauses D-2 and D-3 as reproduced verbatim :-

"PROPOSED AMENDMENT

- XVIII) That, the exam schedule declared on 28.12.2022 is totally violation of rule of procedure framed by respondent No. 2 on 11.04.2022 and quash and set aside the letter dated 28.12.2022. Considering the advertisement itself is not as per the Recruitment Rules not provided any preference to candidates like applicant. The copies of communication dated 28.12.2022 and Rule of procedure dated 11.04.2022 are annexed herewith and marked as "<u>ANNEXURE "A-8"</u> collectively.

7. Plain reading of new prayer Clauses D2 and D3 there is apparent contradiction in the sense that on one hand the applicant has prayed for quashing and setting aside the schedule for screening test which may halt the process of recruitment and, on the other hand the applicant has prayed for keeping one post for each of them vacant subject to decision of O.A. This aspect has been brought to the notice of the learned Advocate appearing for the applicants, who have agreed to re-look in to the proposed prayer clauses and do the needful in this regard, if needed.

8. The applicant has sought stay on screening test scheduled on 23.01.2023 mainly on following three grounds :-

(a) Screening test is being carried out in violation of Rules of Procedure framed by M.P.S.C. dated 11.04.2022.

(b) Appeal against the Order passed by this Tribunal in O.A. No. 1191/2015 has been challenged before Hon'ble High Court of Judicature at Bombay which is pending for adjudication. During pendency of the same the present

9. Clause 10 of the advertisement for the posts stipulates the process of preliminary scrutiny/ screening test and interview. No concrete evidence has been adduced by the applicant to establish that the same is not in accordance with the Rules of Procedure, *framed by M.P.S.C. dated 11.04.2022*.

10. Considering the contingency in which MPSC completes the screening test and provisional list of candidates in descending order of marks secured by them in screening test is prepared and published, then, in our considered opinion, no prejudice is likely to be caused to the applicants as scrutiny of documents of short-listed candidates has already been provided for in accordance with the clause 10 of the advertisement for the ongoing recruitment process.

11. In view of above facts, in our considered opinion, the applicants have failed to establish that balance of convenience lies in their favour. Therefore, we infer that the present three Miscellaneous
