criminal prosecution nor departmental proceeding was pending so as to withhold retiral benefits.

6. As such, what transpires that there was absolutely no legal hurdle for withholding retiral benefits. However, retiral benefits are withheld for more than four years due to sheer laxity and negligence on the post of concerned officials.

7. Indeed, Rule 122 of M.C.S. (Pension) Rules, 1982 specifically provides that the Head of Office shall complete the process of compliance of pension papers no later than six months before the date of retirement of the Government servant. Rules 120 to 122 provides time frame for verification of service record including service book and preparation of pension papers well in advance. Despite this specific provision in Pension Rules, 1982, Respondents did not bother and the Applicant is deprived of his legitimate retiral benefits for more than four years. Lapses, Laxity and negligence on the part of concerned Official is obvious.

8. In view of above, O.A. deserves to be disposed of with suitable direction.

9. O.A. is disposed of with direction to the Respondents to take all necessary steps for updation of service book, verification of service record etc and to ensure release of all retiral benefits of the Applicant as per his entitlement in law within a month from today.

10. The Applicant can redress the grievance of interest independently.

11. No order as to costs.

6. O.A.No.494/2021 is filed by the Applicant in person who stands retired on 30.06.2013 and claims increment due on 01.07.2013. This O.A. is filed along with M.A.No.402/2021 for condonation of delay. The Respondents have filed reply to M.A. as well as O.A.

7. O.A.No.500/2021 is filed by the Applicant who stands retired on 30.06.2018 and he also claims increment due on 01.07.2018. This O.A. is also filed along with M.A.No.580/2021 for condonation of delay. In M.A. as well as in O.A., the Respondent No.3 and 4 have filed Affidavit in Reply.

8. In all these matters common issue arises about entitlement of a Government servant who retired on 30<sup>th</sup> June for grant of increment which falls due on 1<sup>st</sup> July in view of recommendation of 6<sup>th</sup> Pay Commission. The Applicants are relying on the decision of the Hon'ble Supreme Court as well as recent decision of the Hon'ble High Court in *W.P.No.5864/2019 (Pandurang V. Dhumne V/s State of Maharashtra).* The Hon'ble High Court placing reliance on the decision of the Hon'ble Supreme Court allowed W.P. and directions were given to take necessary steps for grant of notional increment which was due on 1<sup>st</sup> July (after retirement).

9. As such, all these O.As are required to be heard together with M.A. since the common question arises for determination. Though today the matters are fixed for final hearing, it is noticed that in O.A.No.950/2019 and O.A.No.1018/2019, the Respondents have not filed reply to O.A. since M.A. and O.A. are required to be heard together, it is necessary to have the reply of Respondents in O.A.No.950/2019 and 1018/2019 also.
