Gaikwad, learned Presenting Officer for the Respondents.</li> <li>2. Learned Advocate has prayed for leave to amend.</li> <li>3. Permission granted. Amendment be carried out forthwith.</li> <li>4. These 5 Applicants who want to get appointed to the post of Health Worker in Male 50% quota as Direct Recruitment in Public Health Department (PHD) are challenging the notification dated 12.01.2022 and also letter dated 02.05.2022 issued by the office of Director, Public Health. By the said letter the PHD has called 20 candidates including these 5 Applicants for verification of their experience certificate.</li> <li>5. Learned Advocate for the Applicants submits that the verification of the experience certificate of these candidates has already been done in October, 2021 by the Respondent and therefore there is no further need of verification of the documents which is going to take place on 24.05.2022 by the Committee pursuant to the Notification dated 12.01.2022.</li> <li>6. Learned Advocate further submits that the applicants were called for verification of experience certificate who have applied for the post of Health Workers in PHD earlier to 12.01.2022 i.e. the date of the impugned notification, therefore, the said Notification is not applicable to the present applicants.</li> <li>7. Learned P.O. submits that she needs time to seek proper instructions from PHD. Moreover Notification of January 2022 is challenged now. Applicants are called for re-verification of their experience certificate so there is no urgency. [P.T.O.]</li> </ol>
