- In the present O.A., the Applicant has challenged the 2. impugned transfer order dated 04.07.2019 whereby he has been transferred from the post of Live Stock Development Officer, Gr.I, Veterinary Dispensary, Velha, Tal. Junnar, Dist. Pune to LSDO, Gr.I, Veterinary Dispensary, Madilage, Tal.Bhudargad, Dist. Kolhapur. The Applicant contends that it being mid-term transfer and not in consonance with Section 4(4)(ii) and 4(5) of the Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred to as 'Act 2005') which requires to be stayed. Though the Applicant was due for transfer but no transfer order has been issued in April or May and, therefore, the Applicant has assailed the transfer order as mid-term transfer.
- In place of Applicant, the Respondent No.2 i.e. Dr. Sadhana R. Firke has been posted but her transfer order is already stayed by this Tribunal in O.A. No.646/2019. Prima-facie, there is no compliance of approval of preceding next Competent Authority as requires under Section 6 of 'Transfer Act 2005'.
- In connected matters in similar situation, this Tribunal has already granted interim relief.
