ORDER

1. Heard Shri A.V. Bandiwadekar, the learned Advocate for the Applicant and Ms. S. Suryawanshi, the learned Presenting Officer for the Respondents.

2. The Applicant has challenged the impugned order dated 12.9.2018 by which he has been transferred from Public Works Sub Division No.1, Shahapur, Thane to Agriculture Construction Sub Division No.13, Aarey Goregaonm Mumbai. It is his contention that he has been transferred at Public Works Sub Division No.1, Shahapur, Thane by order dated 31.5.2016 and he joined the said post on 14.6.2016 and since then he is working there. He has not completed his normal tenure on the present post and place. He is not due for transfer. Not only this, but he is going to retire on 31.7.2019. It is his further contention that the Respondent No.2 who has been transferred and posted at Agriculture Construction Sub Division No.13, Aarey Goregaon, Mumbai is also not due for transfer and he has also not completed his tenure at Aarey Goregaon.

3. It is his contention that he has been transferred by the impugned order dated 12.9.2018 without recommendation of Civil Services Board and without approval of the next higher authority i.e. Hon'ble Chief Minister. It is his further contention that the

impugned order has been issued to accommodate the Respondent No.2. Therefore he has challenged the impugned order by filing this Original Application.

4. Learned Advocate for the Applicant has submitted that the transfer order of the Applicant is in violation of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Office Duties Act, 2005 (hereinafter referred as Transfer Act, 2005). He has submitted that the Applicant has not yet relieved from the present post. He has submitted that the impugned order has been issued to favor the Respondent No.2 and therefore he prayed to grant stay to the execution of the impugned order.

5. Learned P.O. for the Respondents submits that the impugned order has been issued in view of the provision of section 4(4) of the Transfer Act by the Competent Authority i.e. Hon'ble Minister concerned and there is no illegality in it. She has submitted that there is no just ground to grant interim relief. Therefore, She prayed to reject the interim order.

6. On perusal of record it reveals that the Applicant is serving at Public Works Sub-Division No.1, Shahapur, Dist. Thane since 14.6.2016. He has not completed his normal tenure of posting at that place. He is going to retire on 31.7.2019. On perusal of the record produced by the learned P.O. it reveals that the department has proposed the transfer of the Applicant without recommendation of the Civil Services Board. The Competent Authority i.e. Hon'ble Minister made transfer of the Applicant without recording special reasons. There is no special circumstance for the transfer of the Applicant. Prima facie there is no compliance of Section 4(4) of the Transfer Act. Prima-facie it seems that the impugned order has been issued in violation of provision of the Transfer Act. The Applicant has not been yet relieved from his present post.

7. In these circumstances it would be just to stay the execution and operation of impugned order till filing of reply by the Respondents. Hence the execution and operation of the impugned order dated 12.9.2018 is stayed till filing of reply of the Respondents.

8. Issue notice before admission returnable on 10.10.2018.

9. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.
