In the present O.A. it is assertion of the applicant that she holds requisite experience as required for the said post, however, her candidature was wrongly rejected. When the matter was heard on 17.8.2023 for the first time an interim direction was given to respondent No. 3 to issue interview call letter to the applicant and to interview her; however, result of her interview was directed to be subject to outcome of the present O.A.

Learned counsel for the applicant submitted that according to the directions issued by this Tribunal the applicant has been interviewed, however, her number of marks, are not declared because of the order passed by this Tribunal.

3. Learned counsel appearing for the applicant further submitted that now the list of selected candidates has been published by the M.P.S.C. and the Government is also in process of issuing orders of appointment. Learned counsel submitted that if the applicant becomes aware of her marks she may be in a position to decide whether to continue with the present O.A. or to withdraw the same. Learned counsel submitted that the applicant belongs to DTA category and candidate whose name is included in the select list of the DTA category has secured 108.50 total number of marks. Learned counsel submits that in the circumstances, if further directions are issued for declaring the result of the applicant and if it is noticed by the applicant that she has secured less number of marks than the candidates shown to be selected, most probably the applicant may withdraw the present Original Application and if it is noticed that she has secured

more marks than the candidate shown to be selected then she will try to substantiate how she holds requisite experience as prescribed for the said post.

We are also convinced that there may not be any difficulty in giving such further directions to the MPSC.

Learned Counsel for the applicant submits that the order so passed is against the G.Rs. dated 14-09-2018 as well as 16-05-2009 and has also placed on record the order passed by the Division Bench of the Hon'ble Bombay High Court in Writ Petition No.9955/2023 with connected Writ Petitions on 25-08-2023. Learned Counsel for the applicant prayed for same interim relief in the present matter.
- 3. Learned P.O. has opposed for granting any interim relief in the matter. She has sought time for

taking instructions from the department and to file the reply. It is further contended that if the applicant is really possessing the disability certificate certifying her disability, she should not hesitate to appear for medical examination and on that ground prayer for interim relief is opposed.

4. Considering the submissions of the parties and on perusal of the G.Rs. and judgment of Hon'ble High Court as referred above, following order is passed:

ORDER

- [i] Issue notice to the respondents, returnable on 15-02-2024. Till then the order passed by respondent no.4 on 24-11-2023 shall stand stayed.
- [ii] Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- [iii] Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are

put to notice that the case would be taken up for final disposal at the stage of admission hearing.

In the year 1998 i.e. on 06-07-1998, he came to be regularly appointed as Maharashtra Public Service Commission (MPSC) selected candidate on the post of Medical Officer. It is the grievance of the applicant that continuous services rendered by him during the period between 16-08-1995 to 05-07-1998 are not taken note of in his service book. Learned Counsel referring to Rule 30 of the Maharashtra Civil Services (Pension) Rules, 1982 as well as the judgment of the Hon'ble Bombay High Court in **Writ Petition No.603/2018**

in the case of Vijaykumar Ganpatrao Nimbalkar V/s. State of Maharashtra & Ors. delivered on 05-09-2018 and one earlier judgment of the Hon'ble High Court in Writ Petition Bombay No.3690/2005 in case of Anant S. Tambade & Ors. V/s. The Collector, Ratnagiri & Ors. delivered on 19-12-2006 submitted that services rendered by the applicant on the permanent sanctioned post on ad-hoc basis are liable to be considered for the purpose of qualifying services after the services of the applicant are regularized on the same post.

- 3. Respondent no.5 has filed separate affidavit in reply and respondent nos.1 to 4 have filed their joint affidavit in reply resisting the contentions raised in the O.A. It is the contention of the respondents that the applicant cannot claim any right with regard to services rendered between 16-08-1995 to 05-07-1998 since there is no record of entry in service book regarding appointment during the said period. Learned P.O. reiterated the contentions raised in the affidavit in reply and prayed for dismissal of the O.A.
- 4. We have considered the submissions made on behalf of the applicant as well as the State

authorities. It is not in dispute that the applicant was initially appointed as a bonded candidate as Medical Officer. It is also not disputed that on the same post he got regular appointment after the MPSC selected him and since then he worked till he opted for voluntary retirement, which he took in the year 2019. Applicant though has got all the benefits of the period between 16-08-1995 to 05-07-1998, the said period is not recorded in the service book of In the circumstances, when the the applicant. proposal for sanction of pension was forwarded to the Accounts Officer, certain objections are raised. Respondents have not disputed the fact that during the period between 16-08-1995 to 05-07-1998, applicant has worked with the respondents and has also been paid salary and increments of the said period.

5. Two judgments which are relied upon by the learned Counsel for the applicant have dealt with the identical situation, hence, the ratio laid down in the said judgment would squarely apply in the present matter also. Moreover, Rule 30 of the Maharashtra Civil Services (Pension) Rules, 1982 is quite explicit and on that basis case of the applicant

also deserves to be allowed. As provided in the said Rule, after regular appointment qualifying service has to be reckoned from the date of first appointment of the applicant, and as such, respondents need to take note of the service rendered by the applicant from 16-08-1995 to 05-07-1998 and reckon the period of service of the applicant from the said date for the purpose of pension as well as pensionary benefits. Hence, the following order:

ORDER

- [i] Order passed by respondent no.1 dated 18-02-2021 is quashed and set aside.
- [ii] Respondents shall take note of the service rendered by the applicant from 16-08-1995 to 05-07-1998 in his service book and reckon the period of service of the applicant from the said date for the purpose of pension as well as pensionary benefits.
- [iii] O.A. stands allowed accordingly, however, without any order as to costs.
