Learned Counsel relying on the judgment of the Hon'ble Apex Court in the case of Capt. M. Paul Anthony V/s. Bharat Gold Mines Ltd. and Anr. reported in [(1999) 3 SCC 679] submitted that if the departmental enquiry is not stayed the applicant

will be compelled to disclose his defence while crossexamining the said witnesses which will preducially affect the fate of the criminal case filed against him. Learned Counsel in the circumstances has insisted for staying the departmental enquiry till the decision of the criminal case.

3. Respondents have submitted their affidavit in reply and have opposed for grant of any interim relief. Learned P.O. submitted that in the enquiry the respondents departmental have examined almost all witnesses and the enquiry is at final stage. Learned P.O. tendered across the bar communication received to the office of CPO which reveals that the departmental enquiry is at the stage of arguments by the parties after completion of the evidence of both sides.

4. Learned Counsel for the applicant is not disputing the aforesaid factual position. In view of the fact that all the witnesses have been examined by the department and they have also been crossexamined by the applicant, now there remains no propriety in considering the argument advanced by the applicant that his defence in the criminal

prosecution is liable to prejudicially affected. In the circumstances, I see no reason for considering the request of the applicant at this stage for staying the enquiry proceedings. The matter can be finally heard and disposed of since the pleadings are complete.
