2. The Applicant has challenged the impugned order dated 13.12.2019 by which he has been transferred from the post of Forest Guard, Dhas Pimpalgaon (Wildlife), Naigaon, Dist. Beed to Nanded Forest Division.

3. Learned Advocate for the Applicant has submitted that the impugned order has been issued in view of the provisions of Section 4(4) and 4(5) of the Maharashtra Government Servants Regulations of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 ('the Transfers Act' for short). But no provisions of transfer Act, 2005 has been followed by the Competent Transferring Authority. He has submitted that the transfer of the Applicant has been made on the basis of recommendation made by the Chairman (Minister Status), Forest Development Corporation, Maharashtra State, Nagpur without placing the proposal before the Civil Services Board.

4. He has submitted that the impugned order is in contravention of the provision of Transfer Act, 2005. The Applicant has not completed his normal tenure of posting at Beed and he is still working there and therefore, he has prayed to stay the execution and operation of the impugned order.

5. Learned P.O. for the Respondents sought time to file detailed affidavit-in-reply of the Respondents.

6. On perusal of record prima-facie it reveals that the impugned order has been issued without placing the proposal before the Civil Services Board. Prima-facie it seems to be in violation of the provision of Transfer Act, 2005 and therefore, it is just to stay the execution and operation of the impugned order.

7. In view of the above, the execution and operation of the impugned order is hereby stayed till filing of reply by the Respondents.

8. Issue notices to the respondents, returnable on 29.01.2020.

9. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

The cause of action to file the petition arose at Gadchiroli. Therefore, in view of the Rule 6 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988 the Applicant has to file the Original Application before Nagpur Bench of the Tribunal as the cause of action arose within the territorial jurisdiction of that Bench. Hence, the Original Application cannot be entertained in this bench of the Tribunal. Hence, the O.A. is rejected as not maintainable. No order as to costs.
