Relying on the Notification dated 23.2.2022 the learned counsel in the circumstances has prayed for similar interim relief as has been granted in favour of the applicants in O.A. No. 677/2023 and other similar OAs.

3. Learned Chief Presenting Officer has opposed the request so made. After having gone through the contents of the application there remains no doubt that the present applicant is at par with the applicants in O.A. No. 677/2023 and O.A. The applicant therefore, had approached this Tribunal by filing O.A. No. 502/2020. Learned counsel submitted that the said O.A. was allowed and the respondents were directed to release the retiral benefits after obtaining necessary undertaking / bond from the applicant. Learned counsel further submitted that liberty was also given to the

respondents to conduct afresh enquiry as may be permissible under Rule 27 of the Maharashtra Civil Services (Pension) Rules, 1982. Learned counsel submitted that without any such enquiry conducted against the applicant, recovery has been imposed against the present applicant vide impugned order. Learned counsel in the circumstances, has prayed for staying the execution of the said order till disposal of the present Original Application.

4. Learned Presenting Officer has sought time to file affidavit in reply. Learned P.O. further contended that unless whole facts are brought on record, it may be unjust and improper even to accept the prayer for interim relief. Learned P.O. therefore, opposed for grant of any interim relief as has been prayed by the applicant.

5. I have duly considered the submissions made on behalf of the applicant and respondent authorities. I have gone through the documents placed on record. There appears no dispute that the applicant retired in the year 2019 on attaining the age of superannuation. Filing of the O.A. by the

Learned C.P.O. submitted that unless those grounds are known to the Tribunal, it would be unjust and matter of haste if any relief is granted at this stage. He has therefore, opposed for granting any interim relief.

4. It is true that in the order it has been specifically mentioned that the transfers have been effected vide impugned order of about 4 Medical Officers on administrative grounds. Name of the present applicant is at Sr. No. 3 in the said order. It cannot be disputed that the respondents may not elaborate the reasons for the transfers in the order of transfers and to mention that the transfer has been effected on administrative ground is enough; the reasons may be stated in the contemporary record, which may be produced by the respondents along with their affidavit in reply or even before that. However, it has been brought to my notice that in
