Application praying for the directions against the respondents to keep 78 posts of Staff Nurse vacant in the process of recruitment in progress on the strength of advertisement issued on 10.5.2023. The Original Application in which the present Misc. Application has been filed the prayer of the applicants is to fill in 78 vacant posts of Staff Nurse which could not be filled in because of non-availability of the candidates from Exservicemen category for which the said posts were reserved in the advertisement published in the month of February, 2018.
- 3. Shri C.V. Dharurkar, learned counsel appearing for the applicants submitted that there is a checkered history behind the present Original Application as well as Misc. Application. Learned counsel pointed out that after it was noticed that the posts reserved for the candidates

belonging to Ex-servicemen category were not likely to be filled up due to non-availability of the candidates from the said category, the applicants were pursuing the Government to convert these posts and get them available for appointment of the eligible candidates next in the select list as per the social reservation and in order of merit. Learned counsel pointed out that one petition bearing Writ Petition No.4738/2021 (Bade Ratnhari Shridhar & Ors. Vs. State of Maharashtra & Ors.) was there before the Hon'ble Bombay High Court and in the said Writ Petition 'no objection' from the सैनिक कल्याण बोर्ड came to be placed on record. Learned counsel pointed out that there upon the said Writ Petition was disposed of on 14th June, 2021 by the Hon'ble Division Bench with the direction to carry out further process in view of the no objection given by the said सैनिक कल्याण बोर्ड for filling the posts remained vacant because of the non-availability of the candidates from the category of Ex-servicemen.

4. Learned counsel further pointed out that OAs were also filed before this Tribunal bearing O.A. No. 1014/2019 and O.A. No. 95/2020, wherein also the submission was made that the respondents are intending to fill up all 129 vacant posts and in view of such submission made on behalf of the State authorities the said OAs were disposed of. Learned counsel further

pointed out that in the Contempt Petition arising out of non-compliance of the orders passed in O.A. No. 1014/2020 With O.A. No. 95/2020 also the concrete statements were made by the authorities concerned before this Tribunal that all necessary steps are being taken for filling up 78 posts which had remained unfilled because of the non-availability of the candidates belonging to Ex-servicemen category.

5. In the present matter the applicants have placed on record the copies of all those orders passed by this Tribunal. Referring to all those orders, the learned counsel submitted that respondents time and again though gave assurance did not fulfill it and on one or other pretext just killed the time. Learned counsel submitted that had honest and timely steps taken by the respondents for filling up the posts which had remained vacant because of non-availability of the candidates belonging Ex-servicemen category, which was quite permissible in view of the several Government decisions in that regard, probably none of the said posts could have been remained vacant and all eligible candidates who had competed in the year 2018 and whose names were in the merit list would have certainly got the appointments. Learned counsel submitted that some of such candidates have received such appointments,

however, since no concrete steps were taken insofar as 78 posts are concerned, the said posts remained unfilled and the candidates likely the present applicants, who were aspiring for their appointment in order of their merit, ultimately did not get the said opportunity. Learned counsel submitted that though the respondents have come out with the case that such 78 vacancies have been carried forward and accordingly shown in the recent advertisement published in this regard the commitment which was made by the respondents and corresponding right which has accrued in favour of the applicants cannot be dispensed with. Learned counsel submitted that in such circumstances, the applicants have approached this Tribunal by filing the present Misc. Application praying for keeping corresponding number of posts vacant/unfilled till decision of the Original Application.

6. The respondents have filed affidavit in reply to the present application. It is the contention of the respondents that once the said 78 posts have been carried forward and shown as vacancies for the category of Ex-servicemen in the instant advertisement published, the O.A. as has been filed by the present applicants as well as the present Misc. Application, both have become infructuous.

- 7. Learned Presenting Officer has submitted that the advertisement has been published for recruitment of total 3974 posts out of which 597 posts are reserved for Ex-servicemen which include the carried forward unfilled 78 posts in the previous advertisement. Learned P.O. submitted that for the present recruitment most of the recruitment work has been outsourced and the agencies are appointed for the purpose of holding the examination and declaring the result also. Learned P.O. submitted that the recruitment process in pursuance of the advertisement dated 10.5.2023 is at advanced stage and it would be unjust and improper to cause any interference in the said ongoing process. Learned Presenting Officer in the circumstances has prayed for rejecting the application.
- 8. I have duly considered the submissions made on behalf of the applicant as well as the respondents. Apparently, it may appear that when new recruitment process has begun, the written examinations are held and merit list also has been published, the select list published on the basis of the earlier recruitment process must be held to have become infructuous. Argument advanced on behalf of the respondents is also on similar line. The question arises, 'whether the recruitment process held in pursuance of the advertisement

published in the year 2018 and merit list published at the relevant time can be held to have become infructuous in teeth of new advertisement published on 10<sup>th</sup> May, 2023 and commencement of the recruitment process on that basis'. Ordinarily the life of the select list is for a particular period as may be prescribed by the authority concerned or according to rules, if any such provision is specifically made in that regard or till the next recruitment process commences. The instant matter, however, requires to be dealt with a different angle having regard to the peculiar facts involved in the present matter.

9. As noted hereinabove, the applicants have been constantly following the matter and pursuing their demand for filling up the vacant posts, which could not be filled because of non-availability of the candidates from certain categories. As has come on record सैनिक कल्याण बोर्ड has recorded its no objection for filling the posts, which had remained vacant because of non-availability of the candidates from Ex-servicemen category, from the other meritorious candidates considering the social reservation or other conditions laid down therefor. The order passed by the Hon'ble High Court and orders passed by this Tribunal, if read together reveal that for

filling 78 posts, meant for Ex-servicemen which remained unfilled because of non-availability of the candidates from that category, the सैनिक कल्याण बोर्ड has given its written 'no objection' in W.P. No. 4738/2021, before the Division Bench of the Hon'ble Bombay High Court, on the basis of which the said W.P. came to be disposed of.

10. It is the matter of record that in Contempt Petition 29/2020 In O.A. No. 1014/2019, before this Tribunal, the Principal Secretary, Medical Education, submitted an undertaking that unfilled 78 posts meant for Ex-servicemen would be filled in from amongst the eligible candidates in the select list. It has to be stated that during the period of Corona Pandemic insufficient staff in the Government hospitals, in the hospitals attached to the Government Medical Colleges was the burning issue and the Hon'ble Bombay High Court has issued certain direction to the Government to ensure that all vacant posts in the hospitals are filled by giving toppriority. The orders passed by the Hon'ble High Court, as well as, by this Tribunal insofar as filling of 78 posts of Staff Nurse are concerned must be held a mandate given to the Government on the basis of the information brought before them and stand taken by the Government at that time.

- 11. It has to be further stated that though the aforesaid issue was pending for more than a period of one year, no such information came to be placed on record that Ex-servicemen category candidates have become available. In one of the orders, the Tribunal has also observed that there are inbuilt provisions for conversion of posts which are remained to be filled reserved for Ex-servicemen. As such, some steps were required to be taken by the respondents. It has to be stated that undesired reluctance was however, seen on the part of the respondents. In spite of express commitment made by the competent person before this Tribunal, no positive steps were taken by the respondents.
- 12. In view of the fact that issue pertaining to unfilled 78 posts reserved for Ex-servicemen is the subject matter in the contempt petition and OAs referred above which are still pending and the candidates who claimed to be next in the select list after/below the candidates already appointed have been pursuing said proceedings till this date, with a hope that if 78 unfilled posts reserved for Ex-servicemen are filled by other meritorious candidates in the select list, they would certainly get the appointment. The present M.A. or the connected other proceedings cannot be said to have become infructuous.

- 13. After 'no objection' for filling 78 posts reserved for Ex-servicemen was placed on record by the सैनिक कल्याण बोर्ड in W.P. No. 4738/2021 an impression was certainly created that there was no impediment for filling up those 78 posts from amongst other eligible candidates. The present applicants claim to be amongst said candidates. Thereafter the conduct of the respondents' also make believe the applicants as well as this Tribunal that respondents are willing to get filled said 78 posts.
- 14. In premise of the facts and circumstances as aforesaid, if the applicants have now come out with the prayer that said 78 unfilled posts cannot be made part of the vide recruitment process commenced the advertisement published on 10.5.2023 and the said issue needs to be settled in the proceedings, which are still pending, and have therefore, if prayed for an interim relief thereby seeking directions against the respondents to keep 78 posts vacant out of the total posts advertised vide advertisement dated 10.5.2023, according to me the applicants have made out a prima facie case in their favour. I am, therefore, inclined to pass the following order: -

### ORDER

(i) The respondents are directed to keep 7 posts vacant out of 597 posts reserved for Ex-servicemen

category till the decision of the present Original Application.

- (ii) The Misc. Application stands disposed of in the aforesaid terms with no order as to costs.
- (iii) The O.A. to come up for hearing 10.10.2023.

#### **ORAL ORDER:**

Heard Shri V.P. Savant, learned counsel for the applicant and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent authorities.

- 2. Learned C.P.O. has tendered across the bar affidavit in reply on behalf of respondent No. 3 in M.A. Same is taken on record and copy of the same is given to other side.
- 3. This is an application seeking condonation of delay which has occasioned in filing the accompanying O.A. annexed with the present M.A. by the applicant. The delay is stated to be of more than three and half years.
- 4. Learned counsel for the applicant submitted that in fact for all the reliefs, which the applicant have claimed in the O.A. there is continuous cause of action, however by way of precaution, he has filed the present Misc. Application seeking condonation of delay. Learned counsel submits that he could not

have made request for regularization of period of suspension unless concluded from the criminal prosecution and accordingly he has made request but the same has not yet been decided. Learned counsel submitted that since his suspension period has not been regularized, his pension papers cannot be processed. Learned counsel submits that prayers made in M.A. though appears to have been made belatedly, considering the subject matter which pertains to pension and pensionary benefits, there is a continuous cause of action and even if some delay would have occurred, it deserves to be condoned.

5. Learned C.P.O. has opposed for condonation of delay stating that the cause of action had arisen in the year 2011. Instead of moving court, the applicant went on making representation and has approached belatedly and no sufficient reasons are provided for occurrence of such huge delay. Learned C.P.O. submitted that in absence of any sufficient cause made out by the applicant, the delay cannot be condoned. Therefore, he has prayed for rejection of M.A.

6. I have considered the submissions made on behalf of the applicant, as well as, respondents. The applicant has filed the O.A. seeking reliefs in relation to his pension and retiral benefits. Having considered the cause for which the O.A. is filed by the applicant, even if the delay caused in approaching this Tribunal is of a bit longer period, I am inclined to condone the same so that the applicant may get an opportunity to agitate his grievance on merits. Hence, the following order:-

### ORDER

- (i) The M.A. No. 286/2023 is allowed.
- (ii) The delay caused in filing the accompanying O.A. is condoned.
- (iii) Accompanying O.A. be registered and numbered in accordance with law.
- (iv) The M.A. stands disposed of. No order as to costs.
