2. The applicant is challenging the order dated 07-08-2018 issued by the respondent no.3 fixing seniority in the service from the date of entry in the service.

3. The applicant has claimed seniority in the service from the date of filing of the application with the competent authority for enrolling her name in the waiting list of the eligible candidates to be appointed on compassionate ground i.e. from 10-06-2008.

4. Learned Advocate for the applicant has submitted that the applicant has filed application for getting appointment on compassionate ground on 10-06-2008 but her name was not recorded.

Therefore, she approached this Tribunal by filing O.A.No.598/2013, which was decided on 16-07-2015. He has submitted that on the basis of direction given by this Tribunal in the O.A. name of the applicant was included in the waiting list and her seniority was considered from the date of filing of application i.e. from 10-06-2008. He has submitted that thereafter, the applicant was appointed as Group-D employee by order dated 05-07-2018 and she joined service on 09-07-2018. Her date of appointment i.e. 09-07-2018 is considered for the purpose of seniority. He has submitted that the respondents ought to have considered her seniority from 10-06-2008 i.e. when she filed application for getting appointment on compassionate ground to the concerned department.

5. Learned PO has submitted that the applicant has been appointed by order dated 05-07-2018 and she joined service on 09-07-2018 and that date has been considered for seniority as per the rules. Therefore, the respondent no.3 has rightly communicated the applicant in that regard by communication dated 07-08-2018. Therefore, she has prayed to reject the O.A.

6. On perusal of the record it reveals that the applicant has been appointed as Peon on the establishment of respondents by order dated 05-07-2018 on compassionate ground. She has joined duty on 09-07-2018. She entered in the service on 09-07-2018. Therefore, the same date will have to be considered for considering her seniority in the service as per the rules.

7. There is no provision or rule to consider the seniority of the employees who are appointed on compassionate ground from the date of filing the application for compassionate appointment with the department in which the deceased employee was serving. Therefore, there is no merit in the contentions raised by the applicant in that regard. There is no merit in the O.A. Hence, it deserves to be rejected.

8. In view of the discussion in the foregoing paragraphs O.A. stands rejected with no order as to costs.
