The learned CPO then on instructions and after discussion with the above officers informs that in so far as 3 Games of (i) Sepaktakraw, (ii) Karate and (iii) Soft Tennis are concerned, the State Government will take Policy Decision about 'Affiliation' and 'Recognition' of the 'Association' of these '3 Games' as it is under active consideration of the State Government. As State Government is expected to take appropriate decision within 'Two Weeks'; therefore O.A.Nos.635/2024,

As per the rules, the order of 'Re-verification' of 'Sports Certificate' should be 'Reasoned Order' and it should contain 'Time Limit' for challenge in Appeal. Thus, if School Education and Sports Department and Director of Sports, Pune are serious doubt about validity of Sports Certificates of any Candidate or 'Verification Report' or 'Reverification of Sports Certificate' given to any Candidate; then it is always desirable to give audience to concerned Candidates and then pass 'Reasoned Order'. The School Education and Sprots Department can do so hereinafter. However, the above observations be considered for inclusion as 'Policy Decision' by School **Education and Sprots Department**

- 2. This OA has been filed by 59 Van Majdoors claiming relief of Old Pension Scheme (OPS) in place of Defined Contribution Pension Scheme (DCPS) dated 31.10.2005. Ld. Advocate for the applicants points out that applicants were appointed between 1988 and 1998 and were continuously working without break in the office of respondents and thus had worked for more than 240 days every year and were eligible and qualified and were fulfilling the conditions of GR dated 16.10.2012. Ld. Advocate for the applicants submits that services of the applicant were regularized in terms of GR dated 16.10.2012. The applicants had submitted representation through their Union i.e. Maharashtra State Rojandari Van Kamgar Kruti Samiti to get the benefit of OPS instead of DCPS.
- 3. Ld. PO relied on affidavit in reply dated 30.9.2023 filed by Amol G. Jadhav, Assistant Conservator of Forest, Shahapur, Thane. Para 9.1 of the said reply reads as under:
 - "9.1 It is further respectfully submitted that it is not disputed that the applicants were eligible, qualified and fulfilling the conditions of GR dated 16.10.2012 but it is in unequivocal words mentioned in that GR dated 16.10.2012 that by the said GR the respondent no.1 has decided that whoever absorbed as a permanent employee as per said GR will not be entitled for arrears of his/her salary as well as other facility and monetary benefits. It is also stipulated in the said GR that such persons will be entitled for pension as per GR dated 1.6.2012 and not the one given to employees as per GR dated 31.1.1996. The
