No.527/2024'. It is taken on record.3. Learned Advocate for Applicant by 'Additional Affidavit-in-Reply' dated 18.07.2024 on behalf of Applicants in 'O.A. No.522/2024' & 'O.A. No.527/2024' places on record the subsequent action taken by 'Additional D.G. Prison & Correctional Services, Maharashtra State' on 12.07.2024 to revoke their 'Suspension Orders' dated 27.03.2024.4. Learned Advocate for Applicant emphasizes that while revoking 'Suspension Orders' dated 27.03.2024, of Applicants; 'Additional D.G. Prison & Correctional Services, Maharashtra State Pune' should have also reviewed earlier 'Order dated 29.01.2024' of temporary attachment of services of Applicants but instead upon reinstatement on 12.07.2024 the 'Additional D.G. Prison & Correctional Services, Maharashtra State' has again changed places of temporary attachment of services of Applicants from 'Central Jails & District Prisons' of 'Nagpur, Amravati, & Kolhapur' now to 'Central Jails & District Prisons' of 'Nagpur, Sindhudurg & Chandrapur'.

5. Learned Advocate for Applicant draws attention to the contents of Order dated 12.07.2024 wherein words used is 'पुनःस्थापित' to mean that Applicants have been reinstated on posts of 'Jailer Group - 1' under 'Rule 4(5)(a)' of the 'Maharashtra Civil Services (Discipline & Appeal) Rules, 1979'. However, as 'Rule 4(5)(a)' uses both words 'Modification' and 'Revoke'; therefore 'Modification' would mean 'Minor Changes' in 'Suspension Order' while reinstatement will necessitate decision to 'Revoke' earlier 'Suspension Order'. Hence Order dated 12.07.2024 needs to be corrected and words used should mention revocation of 'Suspension Order' dated 27.03.2024 and thereupon reinstatement of Applicants with effect from 12.07.2024.

6. The 'Additional D.G. Prison & Correctional Services, Maharashtra State' is again informed to refer to observations made in 'Para 7' of Order dated 21.03.2024 which were to ascertain if actions for temporary attachment of services of Applicants to 'Central Jails & District Prisons' of 'Nagpur, Amravati, & Kolhapur' had been taken by Order dated 29.01.2024 under provisions of 'Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' or 'The Prison Act, 1894' or 'Maharashtra Prison Manual, 1979' or any other 'Administrative Instructions' of the 'Home Department'. However, even though adequate opportunity has been provided to produce these documents, the 'Additional D.G. Prison & Correctional Services, Maharashtra State' has failed to do so and also no information in this regard received from 'Home Department'.

7. The 'Additional D.G. Prison & Correctional Services, Maharashtra State' is therefore directed to revoke within 'One Week' the Order dated 29.01.2024 of temporary attachment of services of Applicant and thereafter initiate such appropriate action as may be desirable with reference to directions in 'Home Department letter dated 21.02.2024..


