#### ORDER

- 1. Learned Counsel has submitted that Applicant who is working as Medical Superintendent, Rural Hospital, Ghoti, Tal. Igatpuri challenges order dated 31.08.2024 passed by the Respondent under which Respondent transferred the Applicant from the post of Medical Superintendent, Rural Hospital, Ghoti, Tal. Igatpuri, District Nashik to the same post at Rural Hospital, Visarwadi, District Nandurbar and accordingly Applicant be granted all consequential service benefits, as if the impugned order had not been passed. Applicant further prays that the Respondent be directed to follow the G.R. dated 11.07.2000 thereby giving the Applicant the benefits of the choice posting in view that Applicant having rendered the duties in the tribal area and accordingly the Respondent be directed to post the Applicant in any of the vacant post the Applicant in any of the vacant post the Applicant in any of the vacant
  - (i) District Hospital Training Centre, Nashik

2. Learned Counsel has submitted that Applicant is due for transfer. Learned Counsel has submitted that Applicant prays to direct the Respondent to accommodate the Applicant in view of disability suffered by the Applicant to the extent of 75% in his right leg and as such he is entitled to seek the reasonable accommodation in the light of the provisions contained under 'the Rights of Persons with Disabilities Act, 2016' (hereinafter referred as 'Disabilities Act, 2016' for brevity) read with G.R. dated 15.04.2004. He therefore has submitted that the Government should have followed G.R. dated 11.07.2000 by giving choice posting to the Applicant. Learned Counsel has further submitted that the Applicant has performed his duties in Ghoti, Tal. Igatpuri, since 2017, which is Tribal area and is again transferred to Visarwadi, District Nandurbar which is also Tribal area. Applicant has to be given preferential posting by calling options as per G.R. dated 11.07.2000. Learned Counsel has submitted that the Applicant fulfills the condition mentioned in the first paragraph of G.R. dated 11.07.2000 wherein it mentioned about rendering good service of minimum five years. Further he pointed out Clause 2(c) of the said G.R. stating that Applicant was not asked to give three options of his choice of posting. Learned Counsel has also pointed out Exhibit-D which is appreciation letter dated 26.04.2024 received by the Applicant under the provisions of PCNDT Act, 2003. Learned Counsel has also pointed out Exhibit-E which is copy of Unique Disability ID which shows that Applicant is suffering from 76% of locomotor disability. Learned Counsel has also pointed out Exhibit-F which is copy of G.R. dated 15.04.2004 wherein the G.A.D. has observed that the benefits for the disabled Government servants which are not meticulously followed and not extended to such Government employees. Learned Counsel has further pointed out the representation of the Applicant dated 13.09.2024 addressed to the Additional Chief Secretary of Public Health Department praying that he is to be transferred at a particular place. Learned Counsel has also submitted that the provisions of Section 2(h) and (y) of the Disabilities Act, 2016 are not followed where discrimination and reasonable accommodation are defined which are applicable in the present case. Further learned Counsel has also pointed out that Respondent violated sub Section 5 of Section 3 of the Disabilities Act which states that the appropriate government must take necessary steps to ensure reasonable accommodation and sub Section 5 of Section 20 of the Disabilities Act, 2016 which states that the appropriate government can create policies for the posting and transfer of employees with disabilities.

- 3. Learned P.O. has submitted that the Applicant is relieved on 12.09.2024 and he has not joined the place of new posting. Learned P.O. has also informed that on the post of Applicant i.e. Ghoti, Tal. Igatpuri one Dr. Avinash Gore is posted and hence compliance of Section 4(4) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties, Act, 2005 (hereinafter referred as 'ROTA 2005' for brevity) by way of abundant persecution wherein Hon'ble Chief Minister has also given approval, is followed.
- 4. Though the Applicant is relieved from his post and at present has not joined his new posting, considering his physical condition I am not inclined to ask him to join his new posting under protest especially since he has come out with the case and by pointing out that the posts he has choices are vacant till date. On query learned Counsel has submitted that he has handed over the hard copy of the O.A. to the officer from the concern Respondent- Department who is present in the court itself.
