6. The service may be done by hand delivery/ speed post/courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicants are directed to file affidavit of compliance and notice.

7. In case notice is not collected within 7 days or service report on affidavit is not filed 3 days before returnable date, Original Application shall stand dismissed without reference and papers be consigned to record.

8. Heard on the point of interim relief.

9. Applicant has demonstrated from page 19 annexure to the charge sheet that misconduct subject matter pertains to the period 1997-98, while the charge sheet came to be served on 31.1.2006 and applicant has actually retired on 31.1.2006 by superannuation.

10. The inquiry in the charge sheet has led to exoneration, however, the Government has taken a different view and issued show cause dated 21.8.17.

11. The charge sheet itself is in clash with mandatory prohibition laid down in Rule 27 of MCS (Pension) Rules, 1982, being for conduct which is older than 4 years of the date of superannuation.

12. Therefore applicant has made out strong case for grant of interim relief.

13. It is made clear that applicant should submit reply to the show cause notice and additional representation averring violation of Rule 27 aforesaid. State Government shall be free to pass final order after considering the reply to the charge sheet and points agitated in present O.A and foregoing para No. 11. However, final order should not be given effect to if the order is adverse to the applicant.

14. Competent Authority should be free to take decision on the objection as raised by the applicant in the O.A as well as to the reply to the show cause notice submitted by the applicant, without being influenced due to present O.A.

15. In the event decision is taken to drop the charge sheet, filing of affidavit in reply will not be necessary.


