ORDER

1. Heard Shri M.D. Lonkar, learned Advocate for the Applicant and Ms. S.P. Manchekar, learned Chief Presenting Officer for the Respondents.

2. Applicant is seeking interim relief directing the Respondents to recommend his name in select list of 2018 for selection of Non-SCS Officers for appointment to IAS of Maharashtra Cadre U.P.S.C.

3. For the preparation of select list of 2018 process including written examination, interview is already completed but the Applicant's name is excluded from the list of recommendation of U.P.S.C. Therefore the Applicant has approached this Tribunal contending that he has doubt that his name is not recommended to U.P.S.C. only because of non-writing of ACR for part of the year 2010-2011. The interviews are scheduled on 26.12.2019 and 27.12.2019 by U.P.S.C.

4. Learned Advocate for the Applicant has pointed out that the A.C.R.s of the Applicant are excellent and fulfilled requirements of his recommendation to U.P.S.C. He has further pointed out that the issue of non writing of ACRs for the part of the year 2010-011 was already considered by the Respondents at the time of select list of 2017.

That time his name was recommended to U.P.S.C. However, this time Respondents have not recommended his name on the ground of not giving marks of ACR for the part of the year 2010-2011. Applicant has already made representation but it is not responded.

5. Learned C.P.O. for the Respondents referred to G.R. dated 01.11.2011 (page 50) whereby extensive instructions were issued received for writing and maintenance of ACR of the Government servant. Learned C.P.O. in this behalf referred to clause 6 of G.R. which is as follows :-

"६. जेव्हा प्रतिवेदन अधिकारी एखाद्या अधिका-याचा/ कर्मचा-याचा अहवाल त्या अधिका-याने /कर्मचा-याने त्याच्या हाताखाली ३ महिन्यांपेक्षा कमी काम केल्यामुळे लिह् शकत नसेल तेव्हा पुनर्विलोकन अधिकारी जर त्याने त्या कर्मचा-यांचे / अधिका-यांचे काम ३ महिने किंवा अधिक कालावधीसाठी पाहिले असेल तर त्या कर्मचा-याचा / अधिका-याचा गोपनीय अहवाल लिह् शकेल. हा अहवाल पुनर्विलोकित करण्यांची आवश्यकता नाही. मात्र, तशा आशयांचे प्रमाणपत्र गोपनीय अहवालांचे संस्करण करण्या-यांने गोपनीय अहवाल नस्तीवर ठेवावे."

(Quoted from page 54 of O.A.)

6. Adverting to this aspect learned C.P.O. submits that as the ACR was not written by the Reviewing Authority it was not considered for giving marks of 2010-2011. The position of ACR of 2010-2011 of the applicant is as follows :-

- "a) 17.6.2010 to 15.8.2010 Shri Prakash Mahajan, CEO, ZP, Ahmednagar.
- b) 16.8.2010 to 29.8.2010 Shri Vivek Gujar, Incharge, CEO, ZP, Ahmednagar.
- c) 30.8.2010 to 27.9.2010 Shri Prakash Mahajan CEO, ZP, Ahmednagar."

7. As the said period was for less than 3 months regular ACR was not written. However certificate was issued by the competent authority. Interestingly, ACR was written for the period of 5 months i.e. from 28.09.2010 to 02.03.2011 and it was graded as "A+". Indeed as per the Government Resolution dated 10.07.2019 (page 80), paragraph No.2, if NRC period is more than six months then in that event ACR written for the remaining period has to be considered ACR of whole year. In present case, ACR was written for the period of five months for the year 2010-2011 and it was graded as "A+". This being the position we see no reason not to get marks to the ACR of 2010-2011. In other words, Department has completely ignored ACR of 2010-2011 which is not permissible.

8. Learned C.P.O. submits note of Government Resolution, Branch 13. The same is marked 'X' and taken on record. The paragraph 4 of the same is as under :-

"४. प्रसंगत : असेही नमुद करण्यात येते की, प्रतिवेदन अधिका-याचा कालावधी ३ महिन्याहून कमी असेल मात्र पुनर्विलोकन अधिका-याचा कालावधी हा तीन महिन्यापेक्षा अधिक असेल तर अशा प्रसंगी पुनर्विलोकन अधिका-याने गोपनीय अहवाल लिहिणे आवश्यक असून अशा प्रकरणी प्रमाणपत्र देण्यांचा संबंध येत नाही. त्यामुळे या प्रकरणी सदर तरतूद विचारात घेऊन प्रमाणपत्र देण्याची आवश्यकता होती किंवा नाही ही बाब तपासून घेण्यात यावी."

9. It may be noted that the ACRs of five months of the year 2010-11 was reviewed by Shri Jayant V. Gaikwad, the then Divisional Commissioner, Nashik. He was on the same post from 18.08.2009 to 16.07.2012. This being the position Shri Jayant V. Gaikwas himself should have written ACR of the Applicant in terms of clause 6 of the G.R. dated 01.11.2011.

10. As such there seems to be no logic In not giving marks to the Applicant of the ACR of 2010-2011.

11. It seems that no marks were given to the applicant for the ACR 2010-2011 and therefore his name is not recommended to UPSC.

12. In so far as submission of learned C.P.O. regarding non compliance of clause 6 of G.R. dated 01.11.2011 we fail to understand how the applicant can be blamed for non writing of ACR by Reviewing Authority. If this is the only reason then the Applicant cannot be blamed for the same as it was fallure on the part of the Reviewing Authority to write ACRs in terms of clause 6 of G.R. dated 01.11.2011.

13. In view of the above, there is merit in the submission advanced by the learned Advocate for the Applicant and the Applicant is entitled for the interim relief if his name is not recommended only for the reasons of non giving marks for the year 2010-2011.

14. As such, prima facie, Respondents cannot refuse to recommend the name of the Applicant only on the ground of non giving of marks to the ACR of 2010-2011 to the Applicant.

15. They are directed to give appropriate marks to the applicant for the year 2010-2011 and if otherwise eligible his name should be recommended to U.P.S.C. as per the rules. Exercise should be completed immediately as the interviews are scheduled on 26.12.2019 and 27.12.2019. 16. Hamdast and steno copy is allowed.

17. Issue notice before admission returnable on 15.01.2020.

18. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

19. Applicant is authorized and directed to serve on Respondent intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A.. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.


