Heard Ms. Prashesti Shrivastava, learned counsel holding for Shri S.B. Talekar, learned counsel for the applicants and Shri B.S. Deokar, learned Presenting Officer for respondent authorities.

2. Today the present matter is listed for filing rejoinder affidavit by the applicants to the affidavit in reply filed on behalf of respondent Nos. 1 to 4.

3. Learned counsel for the applicants has sought some time to file rejoinder affidavit.

4. Learned counsel for the applicants submitted that because of non-availability of Division Bench, the present matter may not be taken up for final disposal in next few days. Learned counsel submitted that the period of contract to which the applicants have been given extension is likely to be over within few days and the applicants apprehend that on the basis of the Government Resolution dated 16.11.2022 the respondents may indulge in making appointments on

Heard Shri Prashant Nagargoje, learned counsel for the applicant and Shri I.S. Thorat, learned Presenting Officer for the respondent authorities.

2. When the present matter is taken up for consideration, the learned Presenting Officer has tendered across the bar the affidavit in reply on behalf of respondent no. 4. Learned P.O. pointed out that in the affidavit in reply of respondent no. 4 it has been impliedly clarified that the proposal is moved and it is pending for consideration of respondent no. 2. The learned P.O. submitted that within a week necessary instructions would be obtained and has, therefore, sought time of a week to make further submissions. In the interest of justice, time granted as prayed for.

Heard S/shri J.B. Choudhary, Shamsunder B. Patil & K.G. Salunke, learned counsel for the respective applicants in respective matters and S/hri I.S. Thorat, B.S. Deokar & Smt. Deepali S. Deshpande, learned Presenting Officer for the respondent authorities in respective matters.

2. Today, when the present matters are taken up consideration. for Shri I.S. Thorat, learned Presenting Officer submitted the copy of communication dated 18.7.2023 received to the office of Chief Presenting Officer at Aurangabad from the State, more particularly from Medical Education and Drugs Department. Along with the said communication the minutes of meeting held on

17.5.2023 of the Civil Services Board are annexed. The communication along with annexure is taken on record and copy of the said document is provided to the learned counsel appearing for the respective applicants.

3. It is the specific contention commonly raised on behalf of all the applicants that none of them has completed the ordinary tenure on the existing post at the existing station. As has been submitted on behalf of Dr. Ankushe, applicant in O.A. No. 631/2023 he has spent only 9 months on his existing post. As per the contention of Dr. Gaikwad, applicant in O.A. No. 632/2023, he is working as Associate Professor at Aurangabad w.e.f. 10.6.2022. According to the contention raised by Dr. Kachanerkar, applicant in O.A. No. 633/2023 he resumed at Aurangabad on 7.11.2020 and he was transferred at Aurangabad vide order dated 3.11.2020. As per say of Dr. June, applicant in O.A. No. 635/2023, he is working as Associate Professor at Ambajogai w.e.f. 19.3.2021.

4. As has been submitted by Shri Thorat, learned P.O. appearing for State authorities Dr. Gaikwad is working at Aurangabad since the year 2012. Previous to 10.6.2022 he worked as Assistant Professor. According respondents, to Dr. Kachanerkar is working at Aurangabad since 7.11.2020 on the post of Associate Professor. As further submitted by learned P.O. Dr. June is working at Ambajogai since 2015. Prior to year 2015 he worked as Assistant Professor. It was thus, sought to be contended by learned P.O. that Dr. Gaikwad and Dr. June both have completed their ordinary tenure at one station i.e. of 3 years.

5. According to the submissions made on behalf of the applicants the impugned transfers are annual general transfers and as such according to them, the respondents were bound to observe the provisions under Section 4(1), (2) & (3) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay In Discharge of Official Duties Act, 2005 (for short "the Transfer Act, 2005). It has been commonly argued that in all these matters the aforesaid provisions are not followed. It has also

been argued that though from the nature of the orders issued, these orders appear to be of the transfers as are annually made, having regard to the date of transfers these orders are the orders passed midterm or mid-tenure. It has also been argued that the procedure for effecting midterm or mid-tenure transfers has also not been followed.

6. While considering the aforesaid submissions advanced on behalf of the applicants, as well as, the respondents and more particularly while going through the contents of the documents produced on record today i.e. the minutes of the meeting of the Civil Services Board, since it could not be gathered as to by invoking which powers under the Transfer Act, 2005 the impugned transfer orders are issued, a query was made with learned P.O. to state as to which provision has been invoked by the State Government while directing the transfers of these applicants and/or while issuing the impugned orders of transfer. At this juncture, it is also to be noted that in none of the orders any provision has been referred to or cited. Learned P.O. submitted that a concrete submission will be made by him after

taking instructions from the competent authority, as to by invoking which powers under the Transfer Act, 2005, the impugned orders are issued. Learned P.O. therefore, sought time of a week.

7. Learned counsel for the applicants while fairly conceding for providing such time to learned P.O. further submitted that in place of the applicants none other officer has yet been posted. It is their further contention that the applicants are stated to have been relieved one sided. It is not in dispute that Dr. June has not yet been relieved. In view of discussion made hereinbefore and having regard to the submissions made by both sides, I deem it appropriate to pass the following order: -

<u>O R D E R</u>

(i) Issue notice to respondents, returnable on 1.8.2023, till then the respondents shall permit Dr. Rajendra T. Ankushe, Dr. Anil A. Gaikwad & Dr. Nilesh Kachanerkar to discharge their duties of their existing posts. Insofar as Dr. Namdev P. June is concerned, he has not yet been relived from his existing post and shall not be relieved till next date.

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

(vi) S.O. to 1.8.2023.

(vii) Steno copy and Hamdast is allowed to both parties.

2. Learned counsel for respondent no. 6 has sought time to file affidavit in reply on behalf of respondent no. 6. Learned Presenting Officer has submitted the communication dated 18.7.2023 received to the office of Chief Presenting Officer at Aurangabad from the State Government, more particularly from the Medical Education & Drugs Department. Along with the said communication the minutes of meeting held on 17.5.2023 of the Civil Services Board are annexed. The aforesaid document is taken on record and copy of said document is provided to the other side.

3. Learned counsel for respondent no. 6 has submitted the office order dated 17.7.2023 issued by the Dean of Shri. Bhausaheb Hire Government Medical College, Dhule. He also submitted the copy of the office order dated 14.7.2023, whereby the applicant Dr. Bhushan B. Rao has been relieved from the post of Associate Professor in O.B.G.Y. Both the documents are taken on record and copies of the said documents are given to the parties concerned.

4. Learned Presenting Officer has also sought time for filing affidavit in reply. Learned counsel for the applicant has however submitted that till the time respondents file their affidavit in reply an interim order be passed in favour of the applicant, thereby directing the respondents to allow the applicant to continue to discharge duties on the post of Associate Professor in O.B.G.Y.

5. Learned counsel for the applicant submitted that the transfer of the applicant has been ordered only with an object to accommodate respondent no. 6 in his place. Learned counsel submitted that there was no proposal ever moved for the transfer of the

applicant, though such proposals were made for the transfers of his colleague Associate Professors. Learned counsel submitted that present is case of undue favoritism to respondent no. 6. Learned counsel further submitted that there are certain patent illegalities also, which make out a case for grant of interim relief in favour of the applicant. Learned counsel pointed out that the respondent no. 6 was selected for the post of Associate Professor by the M.P.S.C. and vide order dated 18.1.2023 was given posting on the said post of Associate Professor Cancer Diagnostic Centre at Aurangabad. at Learned counsel pointed out that in spite of posting order as aforesaid the respondent no. 6 did not resume the duties of the post on which she was appointed. Learned counsel pointed out that the respondent no. 6 continued to work as Assistant Professor O.B.G.Y. at Government Medical College, Learned counsel further pointed out that Dhule. respondent no. 6 was relieved from the post of Assistant Professor on 17.7.2023. Learned counsel pointed out that when the respondent no. 6 was working as an Assistant Professor at Dhule till 16.7.2023 and had not joined at Aurangabad in

pursuance of the order dated 18.1.2023, it is surprising that the order dated 13.7.2023 shows respondent no. 6 working at Cancer Diagnostic Centre at Aurangabad as an Associate Professor and is shown to have been transferred in place of the applicant at Government Medical College at Dhule. Learned counsel further pointed out that the Civil Services Board has specifically rejected the request of respondent no. 6 for her appointment at Dhule instead of at Aurangabad. Learned counsel submitted that by using political pressure the respondent no.6 has procured the impugned order and only with an intent to accommodate her that the has shifted from Dhule applicant been to Aurangabad in his midterm.

6. Learned Presenting Officer and learned counsel for respondent no. 6 have pointed out that the applicant has been relieved from his existing post on 14.7.2023 and respondent no. 6 has been allowed to resume duties in his place w.e.f. 17.7.2023. In premise of the facts as aforesaid, it has been argued by learned P.O. that the prayer for interim relief has become infructuous and no such order can be now passed.

7. I am, however, not convinced with the submission so made. From the documents, which are produced on record by the applicant, it is apparently revealed that the respondent no. 6 did never join on the place of her appointment made vide order dated 18.1.2023. The documents on the contrary reveal that till 17.7.2023 the respondent no. 6 was discharging his duties as an Assistant Professor at Government Medical College at Dhule. The documents further reveal that though request was made by the respondent no. 6 to give her posting of Associate Professor at Dhule, the said request was turned down by the Civil Services Board. However, it appears that respondent no. 6 got her request approved by the competent authority, since the documents placed on record by the learned P.O. reveal that ultimately the Hon'ble Chief Minister allowed the request of respondent no. 6.

8. The question further arises, even in such circumstances whether the respondents could have given her appointment on the post of Associate Professor at Dhule ? The answer is 'No'.

9. The documents on record reveal that the respondent No.6 was appointed on the post of Associate Professor as direct recruit by the M.P.S.C. vide order dated 18.01.2023. Perusal of the said order reveals that the respondent No.6 was appointed on the said post vide order dated 18.01.2023 on probation. The probation period was of two years and that was to commence after respondent No.6 resumes the charge of the said The documents on record reveal that post. respondent No.6 did not join at the Cancer Diagnostic Centre at Chhatrapati Sambhajinagar in pursuance of the order dated 18.01.2023. The documents further reveal that till 16.07.2023, respondent No.6 was working as an Assistant Professor at Government Medical College, Dhule and was not relieved from the said post. It is thus, evident that respondent No.6 did never take charge of the post of Associate Professor. In the circumstances, even if the respondents were intending to consider the request of respondent No.6, the respondents must have given her an appointment at Dhule on the post of Associate Professor on probation. However, the order dated

13.07.2023 demonstrates that she has been transferred from Cancer Diagnostic Centre at Chhatrapati Sambhajinagar to Shri. Bhausaheb Hire Government Medical College, Dhule. Respondent No.6 who did never join at Cancer Diagnostic Centre at Chhatrapati Sambhajinagar has been shown to have been working at the said place and is shown to have been transferred by invoking the provisions under Rule 4(4)(2) and 4(5)of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005.

10. It is quite apparent that by completely overlooking the fact that the respondent No.6 did not join the post of Associate Professor as per order dated 18.01.2023 and that she was to be given appointment and not the order of transfer, the respondents issued the order dated have 13.07.2023. From the facts as aforesaid there remains no doubt that only with an intention to accommodate respondent No.6 that the applicant has been shifted from Dhule to Aurangabad. The applicant has thus made out prima-facie case for granting interim relief in his favour. After having

considered the entire facts and circumstances, I deem it appropriate to pass the following order:-

ORDER

- (i) Issue notice to the respondents, returnable on 01.08.2023, till then the respondents are directed to allow the applicant to discharge duties as Associate Professor in O.B.G.Y at Shri. Bhausaheb Hire Government Medical College, Dhule.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (iv) This intimation/notice is ordered underRule 11 of the Maharashtra
