2. Learned counsel for the applicant submits that the applicant was appointed initially at Brihanmumbai Police Force as a Police Constable by order dated 23.11.2006. The applicant, however, came to be transferred inter-district from Mumbai to Jalgaon Region in the month of July, 2023. Thus for the first time the applicant came to now that his year of birth is incorrectly mentioned as 1982 instead of 1984 in his service book. Thus the applicant had applied for correction of date of birth by his first representation dated 16.08.2013. In terms of the said representation, by communication dated 30.01.2014, the office of Superintendent of Police, Jalgaon sought information from concerned department of the Mumbai Police Force about the documents annexed with the service record of the

applicant. By communication dated 20.06.2015, the office of Mumbai Police Force has communicated the applicant to directly apply to the Government for correction in the date of birth. In consequence of which the applicant made reminder representations dated 11.08.2015 and 21.07.2016 respectively.

3. Learned counsel for the applicant submitted that by communication dated 31.01.2017 (Annexure 'A-7'), the Special Inspector General of Police, Mumbai along with communication received from the office of Superintendent of Police, Jalgaon submitted the proposal to the respondent No.1 for sanction. However, till this date the respondent No.1 has not accorded sanction and as such the applicant is constrained to approach this Tribunal by filing Original Application for direction to respondent No. 1 to decide the said proposal submitted by the respondent No.2 in this regard.

4. Learned counsel for the applicant submits that in the background of the aforesaid facts there is no delay as such and there is continuous cause of

action as long as respondent No.1 has not taken decision.

5. Learned P.O. has strongly resisted the application seeking condonation of delay and submitted that the delay has not been satisfactorily explained. There is an inordinate delay. Hence, the Misc. Application is liable to be rejected.

6. On perusal of the annexures as pointed out by the learned counsel for the applicant it appears that in terms of the representation submitted by the applicant and on examinations of the documents submitted by the applicant at the time of his appointment for pressing it in the service book, the date of birth appears to have not been mentioned correctively. In the result, the respondent No.2 i.e. the Special Inspector General of Police, Mumbai has submitted the report to the respondent No.1 for sanction to carry out the correction as sought by the applicant. However, it appears that the respondent No.1 has not decided the said proposal till this date. In view of same, I agree with the submissions made on behalf of the applicant that there is a continuous

cause of action as long as the said proposal (Annexure -'A-7') is under consideration of the respondent No.1. In view of same, the delay as shown in the application appears to be a technical and not intentional and hence, I am inclined to condone the same. Hence the following order:-

<u>O R D E R</u>

- (i) M.A. No. 563/2019 is allowed.
- (ii) The delay of 1 year, 5 months and 17 days caused in filing the accompanying O.A. is hereby condoned.
- (iii) Accompanying O.A. be registered and numbered in accordance with law.

With these guidelines, the concerned authorities shall not reject a single application if it fits into the parameters of the judgments delivered by this Court.

[c] In the alternative, let the concerned authorities suo-moto dig out such cases and after scrutinizing the same as regards their entitlment, proceed to grant the benefits as per the judgments of this court, within 120 days.

[d] While undertaking the above exercise, the gratuity/pay fixation/ pension will be re-calculated, so as to be paid to the candidates with arrears as directed above."

4. In terms of the aforesaid directions given by the Hon'ble High Court, the Finance Department has issued Circular dated 28.06.2023 with the specific direction to the concerned departments to decide all such matters as per information available with the department. However, though specifically directed by the Hon'ble High court in the aforesaid W.P., applicants have not been communicated to submit applications for seeking their notional increments along with the arrears which fell due on 1st July of their respective dates of retirement.

5. It appears from the direction issued by the Hon'ble High court in the aforesaid W.P. and in the light of the Circular issued by the Finance Department on 28.06.2023 and considering the dates of retirement of the applicants, the applicants are entitled for the aforesaid benefits. 2. Learned counsel for the applicant seeks leave to insert the prayer clause 'B-1'. Leave as prayed for is granted. The applicant shall carry out amendment forthwith.

3. Learned counsel for the applicant submits that the applicant is working with the respondents, Police Department as a Police Inspector at Police Station Amalner, Tq. Amalner, Dist. Jalgaon. This Original Application is filed in connection with the Annual Performance Appraisal Report (in short 'A.P.A.R.') for the year 2017-2018.

4. Learned counsel for the applicant submits that the respondent No.4 i.e. the Sub-Divisional Police Officer, Amalner, Tq. Amalner Dist. Jalgaon being a reporting authority has written the aforesaid

A.P.A.R. of the applicant for the said year and recorded gradation of the applicant as 9.14 out of 10. However, the reviewing authority i.e. respondent No.3 –the District Superintendent of Police, Jalgaon, Tq. and Dist. Jalgaon has reduced the said gradation from 9.14 to 4.57.

5. Learned counsel for the applicant submits that being aggrieved by the same, the applicant has preferred the representation dated 07.06.2019 (Annexure 'C') before the respondent No. 2 i.e. the Director General of Police, Maharashtra State Mumbai, however, the said representation is still pending. The applicant is seeking direction against the respondent No.2 to decide the said representation as expeditiously as possible in a time bound manner.

6. Learned P.O. submits that the respondent No.2 has separately filed the affidavit in reply and in paragraph No. 3 (v) it is stated as follows:-

"(v) This office has obtained the remarks of the Respondent No.3, i.e. the then the S.P. Jalgaon and now Additional Commissioner of Police, (East Region), Kalyan. The same have been received on 4.2.2020 and the same now put up before the Director General of Police,

State, Maharashtra Mumbai through the Additional Director General of Police (Establishment) for taking an appropriate view of the representation made by the applicant herein on 7.6.2019 and its decision would be communicated to the applicant at the earliest. It is submitted that because of the aforesaid position, only this short affidavit is being filed, without admitting the contentions raised in this Original Application by the applicant."

7. Learned P.O. submits that the appropriate order may be passed.

8. It appears that the representation filed by the applicant against the review of his gradation by respondent No.3 is pending before the respondent No.2 since 2019. As informed by the learned P.O., the respondent No.2 has called the remarks from the respondent No.3 and also from the Additional Commissioner of Police (East Region), Kalyan and the said information was received on 4.2.2020. I find no justifiable reasons in not considering the representation submitted by the applicant for such a long period. In view of same, it would be just and proper to direct the respondent No.2 to decide the representation submitted by the applicant as

expeditiously as possible in time bound manner. Hence, the following order:-

- (A) The Original Application is hereby partly allowed.
