In the affidavit in reply submitted on behalf of the respondents they have admitted that excluding the applicants no.8 and 9 all other applicants are entitled for the refund and the respondents are ready to refund the amounts which have been recovered from them. Shri B.S.Deokar, learned P.O. has re-affirmed the said stand while arguing the present matter and has submitted that the respondents are ready to refund the recovered amounts to the said applicants. Learned Counsel for the applicants submits that only because of pendency of the present O.A. the respondents have not yet refunded the said amounts.

=3= T.A.09/22, T.A.10/22 & O.A.999/22

6. In view of the submissions made and as has been stated by the respondents, it is directed that the respondents shall refund the recovered amounts to the applicants at Sr.No.1 to 7 and 10 to 22, within 3 weeks from the date of this order. In so far as these applicants are concerned, the T.A.No.09/2022 stands allowed to the aforesaid extent.

7. Applicant no.8 and 9 may prosecute the O.A. further. S.O. to 10-07-2023.

T.A.NO.10/2022

8. In T.A.No.10/2022 there are total 12 applicants. They all have a common prayer that on the ground of wrong fixation of pay the respondents have illegally and unauthorisedly recovered the amounts as are mentioned in the chart annexed with the O.A. at paper book page 16 and have sought refund of the said amount in the present application.

9. In the affidavit in reply submitted on behalf of the respondents they have admitted that excluding

the applicants no.3, 5, 6, 7, 8, 10 & 12, applicants at Sr.No.1, 2, 4, 9 & 11 are entitled for the refund and the respondents are ready to refund the amounts which have been recovered from them. Shri B.S.Deokar, learned P.O. has re-affirmed the said stand while arguing the present matter and has submitted that the respondents are ready to refund the recovered amounts to the said applicants. Learned Counsel for the applicants submits that only because of pendency of the present O.A. the respondents have not yet refunded the said amounts.

10. In view of the submissions made and as has been stated by the respondents, it is directed that the respondents shall refund the recovered amounts to the applicants at Sr.No.1, 2, 4, 9 & 11 within 3 weeks from the date of this order. In so far as these applicants are concerned, the T.A.No.10/2022 stands allowed to the aforesaid extent. Remaining applicants may prosecute the O.A. further.

O.A.NO.999/2022

11. In O.A.No.999/2022 there are total 07 applicants. They all have a common prayer that on the ground of wrong fixation of pay the respondents have illegally and unauthorisedly recovered the amounts as are mentioned in the chart annexed with the O.A. at paper book page 18 and have sought refund of the said amount in the present application.

12. In the affidavit in reply submitted on behalf of the respondents they have admitted that the applicants are entitled for the refund and the respondents are ready to refund the amounts which have been recovered from them. Shri B.S.Deokar, learned P.O. has re-affirmed the said stand while arguing the present matter and has submitted that the respondents are ready to refund the recovered amounts to the applicants. Learned Counsel for the applicants submits that only because of pendency of the present O.A. the respondents have not yet refunded the said amounts.

=6= T.A.09/22, T.A.10/22 & O.A.999/22

13. In view of the submissions made O.A.No.999/2022 stands allowed with the following order:

ORDER

- [i] O.A.No.999/2022 stands allowed
- [ii] Respondents shall refund the recovered amount to the applicants in O.A.No.999/2022 within 3 weeks from the date of this order as undertaken by them in their affidavit in reply filed in the present matter.
- [iii] No order as to costs.
