Heard Smt. Vidya Taksal, learned counsel for the applicant and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent authorities.

2. The applicant has preferred the present Original Application seeking following reliefs :-

- "b. Kindly direct the respondents to allow applicant to discharge his duties on post of Linen Keeper under Resp. No. 3.*
- c. Kindly direct the respondents to recruit and adjust posting of new candidate as Linen Keeper on vacant posts at Mumbai or Kolhapur on vacant posts of Sanchita Parab or Jaywant Patil.*
- d. By granting interim relief, kindly direct the Respondents to allow applicant to render his services under Resp. No. 3 subject to outcome of present Original Application till then no any candidate be appoint and post on post of applicant.*
- e. Kindly direct the respondents issue promotion order as Linen Keeper in favour of applicant."*

3. It is the contention of the applicant that he was appointed on the post of Tailor vide the order dated 11.03.2008 in the office of respondent No. 3. He was made permanent w.e.f. 28.03.2008. It is the further contention of the applicant that in the year 2020 i.e. during the period of corona pandemic, Linen Keeper viz. U.S. Dahifale working in the office of respondent No. 3 was infected with corona; he therefore, stopped attending the office w.e.f. 07.08.2020. Because of the absence of said Dahifale, work in the Cloth Section under respondent No. 3 was seriously affected. In order to manage the activities of the said Cloth Section, the applicant was given additional charge of the post of Linen Keeper. It is the further contention of the applicant that in the meanwhile, the person working on the post of Linen Keeper died and additional charge of the post of Linen Keeper was continued with the applicant.

4. In June, 2022, the respondent No. 2 issued new recruitment rules for filling up the technical posts of Group-C all over the State, in which 13 posts were of the Linen Keeper including the post of which the applicant was holding additional charge.

On 11.09.2023, the applicant submitted an application to respondent No. 2 and requested to give regular appointment on the post of Linen Keeper, as he was holding additional charge of the said post from August, 2020. In premise of the facts as aforesaid, it is the prayer of the applicant that the persons, who are selected on the post of Linen Keeper at Aurangabad be adjusted on the posts which are vacant at Mumbai or Kolhapur and the applicant be continued and permitted to discharge his duties on the post of Linen Keeper and shall be regularly promoted to the said post. Learned counsel stating the facts as aforesaid prayed for issuance of notices to the respondents and also to grant interim relief seeking direction against the respondents to allow the applicant to render his services under respondent No. 3 on the post of Linen Keeper.

5. The contentions raised in the O.A. revealed that the respondent No. 2 has promulgated new recruitment Rules and procedure for conduction of competitive online test 2023 with application form and information brochure. The pleadings in the O.A. further revealed that the respondents have resolved

to outsource the work of Linen Keeper. In the circumstances, on 11.07.2022 the applicant submitted representation with respondents not to outsource the work of Linen Keeper and to appoint him on the said post having regard to the fact that he has been holding additional charge of the said post since last couple of months.

6. After having considered the pleadings in the Original Application and after having gone through the documents placed on record, it does not appear to us that the applicant has made out any case even for issuance of notice to the respondents. Merely because the applicant was holding additional charge of the post of Linen Keeper, he is not vested with any right to seek regular appointment to the post of Linen Keeper irrespective of the fact that he held the additional charge of the post of Linen Keeper.

7. According to the applicant, the Linen Keeper is the promotional post and considering the experience of the applicant, he deserves to be promoted on the

said post. It is revealed that on the basis of additional charge held by the applicant of the post of Linen Keeper, the applicant is claiming entitlement on the said posts. It has to be stated that if at all the applicant intends to be appointed or promoted to the post of Linen Keeper, he has to undergo the process prescribed for that and get selected on merits. If it is the case of the applicant that the work of the post of Linen Keeper is outsourced, the Government cannot be asked not to outsource the work of the said post only in respect of respondent No. 3.

8. The applicant has thus failed in making out any case even for issuance of notices to the respondents. The Original Application filed by the applicant deserves to be summarily rejected and it is accordingly rejected. There shall be no order as to costs.

2. The applicants applied for the post of Live Stock Development Officer, Group-A in pursuance of the advertisement published on 14.2.2022. Both the applicants have successfully passed the written examination and also faced the interview. The applicant No.1 has secured 135.50 marks, whereas applicant No. 2 has secured 131.50 marks. Both the applicants had applied from the open female category while filling the application form. Since both the applicants were not falling under the category of Non-Creamy-Layer, information as against the said column is recorded by both the applicants as "No" i.e. they are not falling in the category of Non-Creamy-Layer. In the application form itself, therefore, it has appeared that their candidature will not be considered for female reservation.



3. Learned counsel appearing for the applicants submitted that now in view of the Government Resolution dated 4.5.2023 the aforesaid condition has been cancelled and the benefit of the said G.R. is made applicable to the recruitment process carried out pursuant to the advertisement No. 83/2021 and to all recruitment processes which have started or commenced after publication of the result of the said advertisement No. 83/2021. Learned counsel submitted that advertisement No. 83/2021 was published on 17.9.2021, whereas the advertisement which is subject matter of the present application bearing advertisement No. 12/2022 was published on 14.2.2022. Learned counsel submitted that in such circumstances both the applicants are entitled for the benefit of the G.R. dated 4.5.2023. Learned counsel submitted that in general merit list, which has been annexed in the present matter, against the names of the present applicants the information whether the applicants are claiming reservation for female candidates is kept blank meaning thereby that they are not be considered for appointment in the said quota. Learned counsel submitted that considering the general merit list and having regard to the benefit given vide G.R. dated 4.5.2023 both the applicants are likely to be selected. Learned counsel submitted that 41 seats are reserved for female open and

in order of merit applicant No. 1 is at Sr. No. 31 and applicant no. 2 is at Sr. No. 41. Learned counsel in the circumstances has prayed for staying further recruitment process till the decision of the present Original Application.

4. Learned Chief Presenting Officer has sought time to file affidavit in reply to the contentions raised in the Original Application, as well as, the prayers made therein. Learned C.P.O. however, submitted that the benefit of the G.R. dated 4.5.2023 may not be claimed by the present applicants since the benefit under the said G.R. has been made applicable to the advertisements which are published after the result of advertisement No. 83/2021 was published. Learned C.P.O. submitted that from the documents it is quite evident that the result of the said advertisement No. 83/2021 was published on 29.9.2022 and the advertisement in the present matter has been published prior to that i.e. on 26.9.2022 and, as such, apparently the benefit of the said G.R. may not be available to the present applicants. Learned C.P.O. submitted that in the circumstances no case is made out for grant of interim relief in favour of the present applicants.

5. We have duly considered the submissions made on behalf of the applicants, as well as, the respondent authorities. We have also perused the documents placed on record. Government Resolution dated 4.5.2023 is crucial document in the present matter. Vide clause 05 of the said G.R. the benefits under the said G.R. are made applicable to the candidates, who participated in the recruitment carried out in pursuance of the advertisement no. 83/2021, as well as, recruitment processes carried out after declaration of the result of the examinations held for the recruitment carried out vide advertisement no. 83/2021.

6. The aforesaid clause 05 does not seem to have been correctly interpreted by the respondents. The argument as has been made by the learned C.P.O. that the benefit of the said G.R. cannot be given to the candidates in the present recruitment process, which is subject matter of the present O.A., as it was commenced on 26.9.2022, whereas the result of the advertisement no. 83/2021 was published on 29.9.2022 is also difficult to be accepted. When the G.R. dated 4.5.2023 is made applicable to the recruitment process carried out in pursuance of the advertisement no. 83/2021, it has to be made applicable to all recruitment processes, which are commenced thereafter or else, it would amount to

discrimination. The applicants, therefore, have made out a prima-facie case for grant of interim relief as has been prayed by them. Though the learned counsel for the applicants has sought interim relief, thereby staying the entire further process of appointment, we are not inclined to accept the said request. According to us, it would serve the purpose if the respondents are directed to keep 02 posts vacant till filing of the affidavit in reply by them. Hence, the following order :-
