The requisite limitation period of one year for filing the O.A. was expired on 25.09.2020 i.e. during the COVID-19 pandemic situation.

3. The accompanying O.A. along with the present Misc. Application is filed on or about 25.01.2021 i.e. also during the COVID- 19 pandemic situation. However, there is an order of Hon'ble Apex Court in *sue-motu* petition that limitation period is exempted, if the cause of action is arisen during the period from

3. It is a settled principle of law that the expression “sufficient cause” is to be construed liberally. Considering the facts and circumstances of the case, refusing to condone the delay is likely to defeat the cause of justice at the threshold. In view of the same, in my considered opinion, this is a fit case to condone the delay. Hence, I proceed to pass following order :-

**ORDER**

1. The M.A. No. 34/2021 is allowed.
2. The delay of 118 days caused in filing the accompanying Original Application is hereby condoned.
3. Accordingly, the M.A. stands disposed of. The Registry is directed to register and number the accompanying O.A. in accordance with law by taking into account other office objection/s, if any.
