2. In the present Contempt Petition willful disobedience is alleged of the following order passed in O.A. No. 526/2011 on 20.8.2018 :-

“(i) O.A. No. 526/2011 is partly allowed.

(ii) Impugned order/letter issued by the respondent no. 3 Director of Education, Aurangabad Division, Aurangabad dated 11.05.2009 referring the letter of respondent no. 2 dated 28.04.2008 obtained by the applicant under Right to Information Act on 29.10.2010 is quashed and set aside.

(iii) Respondents are directed to reconsider the decision given vide letter dated 11.05.2009 and shall consider the aspect as to whether the absence period of the applicant from 01.07.1980 to 30.06.1989 can be adjusted towards any kind of leave as may be admissible to the applicant, such as earned leave, half pay leave or extraordinary leave or leave without pay etc.

(iv) Respondents are directed to consider absence period of the applicant from 01.07.1989 to 31.10.2001 as compulsory waiting period/extraordinary leave, as admissible, as per the provisions of M.C.S. (General Conditions of Service) Rules, 1981.

*(v) After taking decision as aforesaid, the respondent no. 1 to 3 shall take decision as regards pension and pensionary benefits that can be granted to the applicant.*

*(vi) Considering the fact that period of absence is more than 9 years, and the respondents may have to go through the vast record, all the exercise as above shall be completed as early as possible and in any case within 6 months from the date of this order.*

*(vii) There shall be no order as to costs.”*

3. According to the learned counsel for the petitioner despite availing lot-of time and opportunities, the order has not been complied with and wrong reasons are assigned for non-compliance. During the course of hearing we have also passed certain orders clarifying the import of the original order passed in O.A. No. 526/2011. In spite of that the latest affidavit-in-reply has been filed justifying the action of not complying with the order. In para no. 5 of the earlier affidavit-in-reply filed by the Officer concerned who was then in-charge it has been averred thus :-

*“5. I further most humbly say and submit that, the Office of the deponent in response to the aforesaid order (para III) considered the aspect as to whether the absence period of the applicant from 01.07.1980 to 30.06.1989 can be adjusted toward any kind of leave as may be admissible to applicant, such as earned leave, half pay or leave or extraordinary leave or leave without pay etc. The office of the deponent had requested guidance from the Finance Department. Upon which the Finance Department had sanctioned the leave of the applicant as special case and the absence period of applicant from 01.07.1980 to 30.06.1989 has been granted as exceptional Leave (without pay and without allowances) and upon a condition that this leave cannot be considered for pensionary and other service purposes. The decision is communicated to the office of the Deputy Director of Education, Aurangabad vide letter dated 17.8.2020.*

*Hereto annexed and marked as **ANNEXURE R-1** is the copy of communication letter dated 17.8.2020 for kind perusal of this Hon'ble Tribunal."*

4. The respondents are stuck up to the aforesaid stand, which is apparently illegal. If the leave in the relevant period was sanctioned as extra-ordinary leave that too with the concurrence with the Finance Department, now it is not open for the respondents to say that it shall not be counted for the purpose of pension. If the tenor of the order passed in O.A. No. 526/2011 is considered it appears that endeavor was to see that the applicant completes the period of qualifying service required for becoming entitled to pension. Accordingly the period in which the applicant was absent from duty has been held as extra-ordinary leave by respondent no. 1. It was quite obvious that the applicant was not to get any monetary benefits of the said period, we however, fail to understand why the respondents have further added that the said period will not be counted for the purposes of pension also. As we have mentioned earlier the only purpose for considering the request of the applicant to treat the period of absence in the relevant period as extra-ordinary leave was that he may complete the period of qualifying service making him entitled for pension. If that also has not to be granted then the order treating the period of absence as an extra-ordinary leave becomes futile. Moreover, the decision of the respondents not to consider the said period even for computing the qualifying service is contrary to rule 35 of M.C.S. (Pension) Rules, 1982. The said rule reads thus :-

**“(35. Counting of leave for pension. - ”**

*All leave during the period of continuous service for which leave salary is payable and all extra-*

*ordinary leave granted on medical certificate shall count as qualifying service for pension.)*

+Substituted by Notification No. PEN.1001/29/SER-4, dated 5.2.2001 w.e.f. 1.2.2001”

5. Having regard to rule 35 of the M.C.S. (Pension) Rules, 1982 quoted above and the import of the order passed by this Tribunal in O.A. No. 526/2011 prima-facie it appears that there is willful disobedience of the order passed by this Tribunal, by respondent no. 1. In the circumstances, we admit the present petition as Contempt Petition and direct the Registry to issue notice to respondent no. 1 in Form No. III as prescribed in Rule 8(i)(b) of Maharashtra Administrative Tribunal (Contempt of Courts) Rules, 1996. It is clarified that one of the Members in the present Division Bench being Vice Chairman of the Maharashtra Administrative Tribunal, this Bench is competent to initiate contempt action against the concerned respondent.
