2. Learned Counsel for the applicant had brought to our notice the decisions taken by the authorities in the interregnum and submitted that ultimately, the decisions taken by the authorities have also not been implemented and now in the affidavit in reply, the respondents have come out with a defence that original applicant was not entitled for any pensionary benefits, and consequently, the family members of the said applicant, who died during the pendency of the O.A. itself, also cannot be held entitled for the family pension.

=2= C.P.NO.30/2019 IN O.A.NO.526/2011

3. We, at this juncture, may not make any observation on the merit of the case. The respondents are considering the services rendered by the applicant only prior to 01-07-1980, which period comes to around 14 years and 10 months and have therefore declined the right of the applicant for receiving pension.

4. In O.A.No.526/2011 by order dated 20-08-2015, this Tribunal has directed the respondents to consider in accordance with law if the period between 01-07-1980 to 30-06-1989 can be adjusted towards any kind of leave as may be admissible to the applicant, such as earned leave, half pay leave or extraordinary leave or leave without pay etc. The Tribunal has further directed to consider the absence period of the applicant from 01-07-1989 to 31-10-2001 as compulsory waiting period/extraordinary leave, as admissible, as per the provisions of Maharashtra Civil Services (General Conditions of Service) Rules, 1981.

5. The learned Counsel has brought to our notice decision taken by the respondents to treat absence period

of the applicant from 01-07-1989 to 31-10-2001 as extraordinary leave. However, finally the respondents have held that the applicant is not entitled for any pension since he has not completed the qualifying period of service for to be entitled for pension.

6. After having considered the submissions made by the learned Counsel for the petitioner and after having gone through the record, it *prima facie* appears to us that, even if the period of absence of the applicant in between 01-07-1980 to 30-06-1989 is kept aside, the fact remains that the period of absence between 01-07-1989 to 31-10-2001 is directed by the Tribunal to treat the same as compulsory waiting period/extraordinary leave. In the circumstances, respondents are under an obligation to consider the said period while computing the period of qualifying service of the applicant.

7. As has come on record, prior to 01-07-1980, the applicant has admittedly worked for the period of 14 years and 10 months. If the compulsory waiting period from

01-07-1989 to 31-10-2001 is added in the said period, the service period of the applicant exceeds 20 years, which *prima facie*, would make him entitled for pension in his lifetime and thereafter to his family.

8. In the circumstances, according to us the respondents shall re-consider the decision taken by them on or before the next date.

9. Learned P.O. submits that within 4 weeks the statement in this regard will be made and affidavit in reply will be filed in that regard. Matter, therefore, stands adjourned to 15-06-2022.

When the present petition is taken up for consideration, learned P.O. has placed on record copy of order dated 21-03-2022 passed by the Superintendent of Police, Parbhani directing initiation of departmental enquiry against the contempt petitioner. Said document is taken on record. We fail to understand why on previous date i.e. 18-04-2022, this document was not produced on record ?

3. The present contempt petition is arising out the order passed in O.A.No.70/2018 on 11-07-2018. We deem it appropriate to reproduce hereinbelow the entire said order:

2. Without going in to the merit of the case as to whether the present applicant is suffering minor punishment on the proved ground, this Original Application can be disposed of simply on the ground that the respondent No. 3 i.e. the Superintendent of Police, Parbhani is not the disciplinary authority for the present applicant who is and was the Assistant Police Inspector during the relevant period.

3. Schedule-I of Rule 5 of the Bombay Police (Punishment and Appeals) Rules, 1956, would show that Superintendent of Police is the disciplinary authority for Sub-Inspectors, Assistant Sub-Inspectors, Head Constables and Constables. The applicant is admittedly a Assistant Police Inspector and therefore, the Deputy Inspector General of Police would be the disciplinary authority for the applicant.

4. On the above sole ground, the present Original Application is allowed without any order as to costs and the impugned punishment imposed by the respondent No. 3 vide order dated 17.11.2016, Annexure A-10, page no. 47 is hereby quash and set aside. The respondent No. 1 or the competent authority would be at liberty to take fresh action, if any according to rules."

4. Bare reading of the said order reveals that the order

dated 17-11-2016 was quashed and set aside by the Tribunal and the liberty was given to the respondents to take fresh action in accordance with rules. We also deem it appropriate to reproduce hereinbelow the order passed

5. From the contents of the order passed in the O.A.No.70/2018, it is quite evident that the order of punishment was set aside by the Tribunal only for the reason that it was passed by an officer who was not competent to pass such order. We further note that during the course of hearing of the present petition, it was

suggested to the respondents that, as directed by this Tribunal, the competent officer may pass the necessary orders. However, instead of doing so, now a documents has been submitted on behalf of the respondents which reveals that the respondents have now decided to initiate fresh departmental enquiry against the contempt petitioner.

6. We do not wish to make any comment on the action initiated as mentioned above by the respondent no.3. It, however, *prima facie* appears to be a case of willful disobedience of the order dated 11-07-2018 passed by this Tribunal in O.A.No.70/2018. In the circumstances, we direct the Registrar of this Bench to place the matter before the Hon'ble Chairperson for initiation of the Contempt Proceedings against the respondent no.3 in the present petition, viz; Shri Jayant Meena, Superintendent of Police, Parbhani.

He was put under suspension by order dated 10.07.2005. He was acquitted from the corruption case on 18.10.2011.

Thereafter by order dated 02.01.2012 he was reinstated in service but the suspension period is not considered as duty period and requisite payments in that regard are not made to him. Therefore, he filed Original Application along with this delay condonation application seeking requisite relief.

4. It is the contention of the applicant that before filing of the present proceedings, he received letter dated 20.04.2018 from the office of respondent No.4 i.e. the Superintendent of Police, Jalgaon whereby it is stated that appeal against acquittal is pending before the Hon'ble High Court of judicature at Bombay Bench at Aurangabad and therefore the decision will be taken about the leave encashment in due course of time.

5. The application is opposed by the respondent No.4 by filing affidavit-in-reply of one Dattatraya Khushalsingh Pardeshi working as Police Inspector (Control Room), in the office of Superintendent of Police, Jalgaon. Thereby he denied adverse contentions raised by the applicant and contended that no

sufficient cause has been shown by the applicant for condonation of delay.

6. After having considered the pleadings and documents on record, it appears that the applicant was pursuing his claim of regularization of suspension period. He made representation dated 09.07.2018 (Exh. 'A-3' of O.A.). It also appears that before that the applicant received communication dated 20.04.2018 from the respondent No.4 stating that appeal against his acquittal is pending and payment of leave encashment will be considered in due course.

7. Learned Advocate for the applicant also stated that due to filing of appeal against the acquittal by the respondents, the applicant was under impression that he would not get benefits and therefore, the applicant did not take steps. Not taking steps cannot be said to be deliberate and intentional.

4. It is, however, stated that after registration of crime, the applicant was put under suspension by order dated 12.11.2006 and after his acquittal from the said criminal case, the applicant was reinstated in service by order dated 12.07.2010 by the respondent No.4. The applicant stood retired on 31.05.2016. However, the applicant has not been paid his dues towards gratuity, earned leave, commutation of pension etc.

5. Moreover, the period of absence on account of suspension from 12.11.2006 to 12.07.2010 was not considered as duty period. After retirement only, the applicant made representation dated 12.07.2018 ventilating his grievances. However, his grievances are not considered. Hence applicant filed Original Application along with delay condontion application.

6. It is further contended that considering the date of representation there is no delay. However, even if the delay as calculated by the office is considered, it is

not deliberate. The applicant has good case on merit. Hence, this application.

7. Thereby he denied adverse contentions raised by the applicant and contended that no sufficient cause has been shown by the applicant for condonation of delay.

8. After having considered the facts of the case as pleaded in the O.A. and supported documents on record, it seems that there is delay of about 8 years 7 months and 16 days caused in filing the Original Application. In this regard some negligence can be attributed to the applicant in not approaching the Tribunal in time. However, the same negligence cannot be said to be deliberate or gross one.

9. During the course of arguments, learned Advocate for the applicant submitted that because of filing of appeal against acquittal by the respondents,

the applicant was under impression that he would not get dues. The said reason cannot be said to be unusual.

10. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. Refusing to condone the delay is likely to defect the cause of justice at the threshold. In the circumstances, in my considered opinion, this is a fit case to condone the delay of 8 years and 7 months and 16 days caused in filing the Original Application by taking liberal approach and by imposing moderate costs upon the applicant. I compute the costs of Rs.1,000/-(Rs. One Thousand only) on the applicant. I therefore proceed to pass the following order: -
