

- 4. We find that the point of view expressed by the Government is on the lines of observations of the Hon'ble Supreme Court judgment in case of R.K. Sabharwal Versus State of Punjab 1995 AIR 1371, 1995/SCC(2) 745.
- 5. It is thus evident that even according to the Government the promotions have to be effected in strict adherence to the cadre strength. In view of the foregoing clarifications, the Government would be free to effect promotions taking into consideration the cadre strength and by reckoning the roaster points to be observed for effecting promotions.
- 6. We expect that in the foregoing record and observations the State ought to make a positive statement instead of attaching contingencies.
- 7. For enabling the Government to make a statement, the case is adjourned 18.07.2017.
- 8. Steno copy and Hamdast is allowed to learned P.O.. Learned P.O. is directed to communicate this order to the Respondents.


